*Current Annualized Distribution Rate is the Fund's most recent distribution, expressed as an annualized percentage of the Fund's current market price per share. Based on our current estimates, we anticipate that approximately \$0.0825 is paid from ordinary income or capital gains and \$0.0000 of the distribution represents a return of capital. 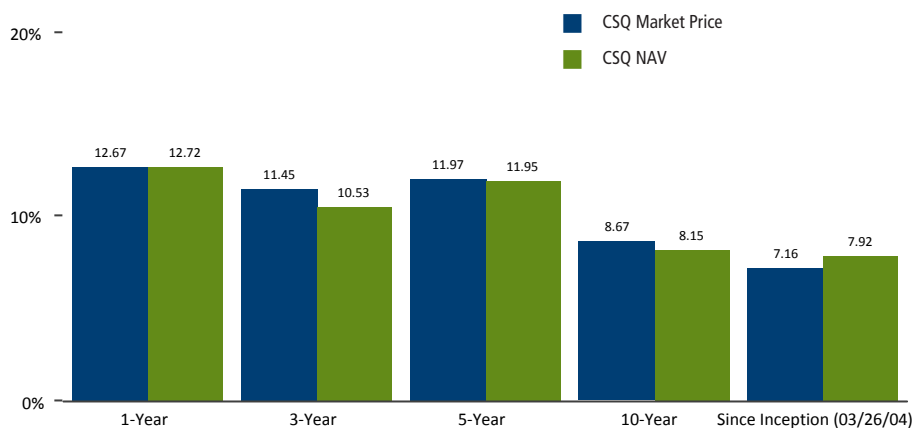
Fund Objective

Investor Profile

The Fund seeks to offer investors equity participation and an attractive monthly distribution. By combining equities, convertible bonds and higher yielding corporate securities, the Fund seeks to generate capital gains as well as income, taking advantage of its flexibility to manage risk and reward over the full course of a market cycle. In effect, the Fund seeks to participate in long-term upward trends of the equity markets with the possibility of a stable monthly distribution.
