John Koudounis, Calamos Investments CEO, Shares Main Stage with Eric Trump at Bitcoin 2026 Las Vegas

Chicago, Illinois, April 23, 2026 — John Koudounis, President & CEO of Calamos Investments, will speak on the main stage at Bitcoin 2026 Las Vegas. Eric Trump, Co-Founder of American Bitcoin, will join Koudounis for the panel titled "From American Hashrate to Wall Street: How Bitcoin Benefits the U.S." on Wednesday, April 29, from 12:00–12:30 p.m. PT. Eric Balchunas, Senior ETF Analyst at Bloomberg Intelligence, will moderate.

This will be the second time Koudounis and Trump have shared a stage. The two last appeared together on a panel titled "Global Shifts – Opportunities in Developed Markets," during the World Economic Forum in Davos this past January.

At Bitcoin 2026 Las Vegas, Koudounis will discuss how Bitcoin is a strategic asset, and America's ability to lead the global digital economy depends on getting its approach right.

Few executives on Wall Street have followed Bitcoin as long or as closely as Koudounis. After eight years of rigorous research, and under Koudounis' leadership Calamos translated that conviction into action — becoming the first asset manager to launch downside-protected Bitcoin ETFs.

"The retail investor is experiencing just how volatile Bitcoin can be — and this is the first time we've seen that volatility in the mass investor era," said Koudounis. "We've been studying this asset for eight years. Times like these are exactly why we built our protected framework, and exactly why Bitcoin's role in America's financial future has never been more important to get right."

Calamos Protected Bitcoin ETFs[®] are built for investors who believe in Bitcoin's long-term potential but aren't willing to absorb unlimited downside to get there. Each ETF offers exposure to bitcoin's price, up to a stated cap, with 100%, 90%, or 80% downside protection over an approximately one-year outcome period, before fees and expenses — using U.S. Treasuries and options on the Cboe Bitcoin US ETF Index.

The result: a regulated, exchange-traded path to Bitcoin that doesn't require betting the house.

Calamos's Laddered Protected Bitcoin ETFs take it a step further, bundling multiple quarterly outcome periods into single-ticker solutions for continuous, diversified protected exposure.
