OVERVIEW

The UCITS fund invests in global convertible securities with the aim of rebalancing risk/reward while providing growth and income.

The fund is actively managed and is suitable for long-term investors.

The fund uses the Refinitiv Global Convertible Bond Index and MSCI World Index as comparative benchmarks but not to constrain the fund's portfolio or as a target for performance.

Ratings are relative, subjective and not absolute standards of quality, represent the opinions of the independent, Nationally Recognized Statistical Rating Organizations (NRSRO), and are adjusted to the Standard & Poor's scale shown. Ratings are measured using a scale that typically ranges from AAA (highest) to D (lowest). The table excludes equity securities, cash and cash equivalents.

Bond – Global Category funds invest principally in convertible securities of issuers from around the world. Unmanaged index returns assume reinvestment of any and all distributions and, unlike fund returns, do not reflect fees, expenses or sales charges. Investors cannot invest directly in an index. **Alpha** is a measurement of performance on a risk adjusted basis. A positive alpha shows that performance of a portfolio was higher than expected given the risk. A negative alpha shows that the performance was less than expected given the risk. **Beta** is a measure of the volatility, or systematic risk, of a security or a portfolio in comparison to the market as a whole. **Delta** expresses the convertible's sensitivity to changes in the stock price. It expresses the change in the convertible price per unit of change in the underlying stock price. **Sharpe ratio** is a calculation that reflects the reward per each unit of risk in a portfolio. The higher the ratio, the better the portfolio's risk-adjusted return is. **R-squared** is a mathematical measure that describes how closely a security's movement reflects movements in a benchmark. **Standard deviation** is a measure of volatility.
