WHAT'S NEW

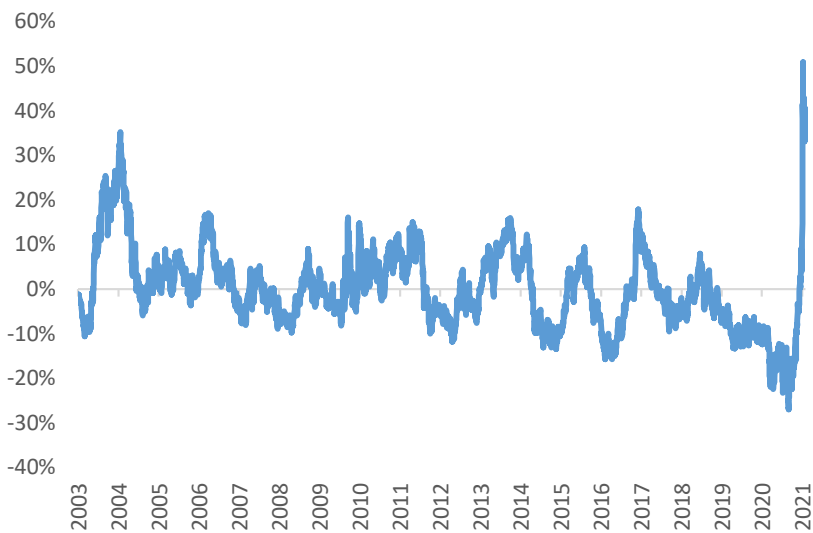
More of the same...small caps continued their winning streak in January, outperforming large caps once again, this time by 585 basis points (Russell 2000 less Russell 1000). This extends the streak to five months in a row. Remarkably, despite the run, small cap valuations are still below average relative to large caps. This illustrates how stretched to the downside small caps were when the streak began.

The real superstars for the month were the micro caps—the smallest of the small. These stocks meaningfully outperformed in January. Another interesting development during the month related to the performance of stocks with high short interest, whereby investors are disproportionately positioned in hopes of a stock price decline. In some wild price movements, fueled by a ramp in retail trading activity, these heavily shorted stocks were exceptionally strong performers, rising sharply, especially during the final week of January.

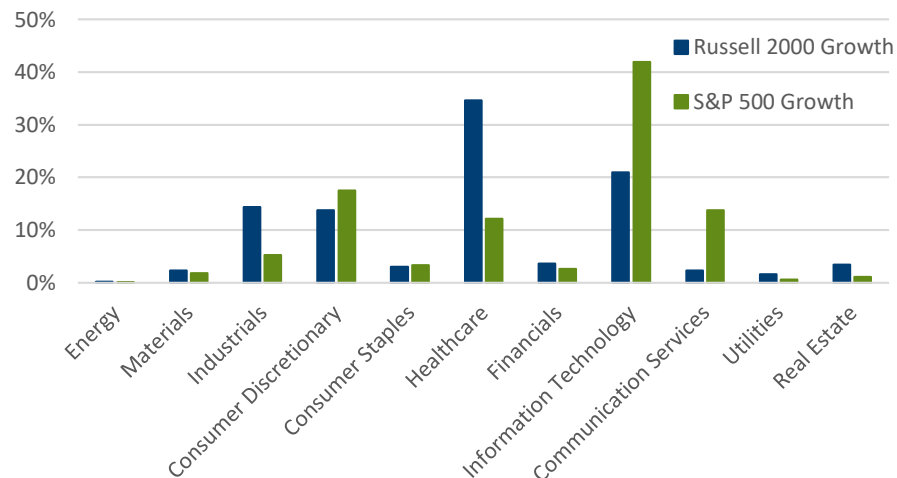

GICS SECTOR ALLOCATIONS (NET)



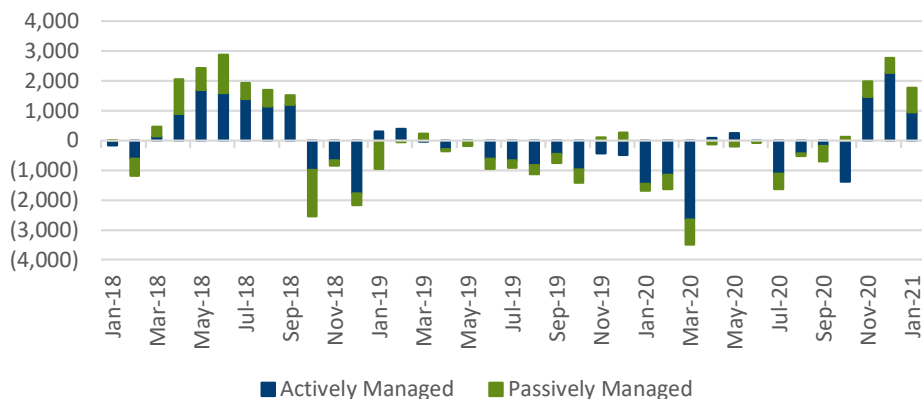

It includes those Russell 2000 companies with lower price-to-book ratios and lower forecasted growth values. The **Russell Microcap Index** measures the performance of the microcap segment of the U.S. equity market. Microcap stocks make up less than 3% of the U.S. equity market (by market cap) and consist of the smallest 1,000 securities in the small-cap Russell 2000® Index, plus the next 1,000 smallest eligible securities by market cap. The **Russell Microcap Growth Index** measures the performance of the microcap growth segment of the U.S. equity market. It includes Russell Microcap companies that are considered more growth oriented relative to the overall market as defined by Russell's leading style methodology. The **Russell Microcap Value Index** measures the performance of the microcap value segment of the U.S. equity market. It includes Russell Microcap companies that are considered more value oriented relative to the overall market as defined by Russell's leading style methodology.

The **S&P 500 Growth Index** measures growth stocks using three factors: sales growth, the ratio of earnings change to price, and momentum. S&P Style Indices divide the complete market capitalization of each parent index into growth and value segments. Constituents are drawn from the S&P 500. **Standard deviation** is a measure of volatility. **Sharpe ratio** is a calculation that reflects the reward per each unit of risk in a portfolio. The higher the ratio, the better the portfolio's risk-adjusted return is.
