WHAT'S NEW

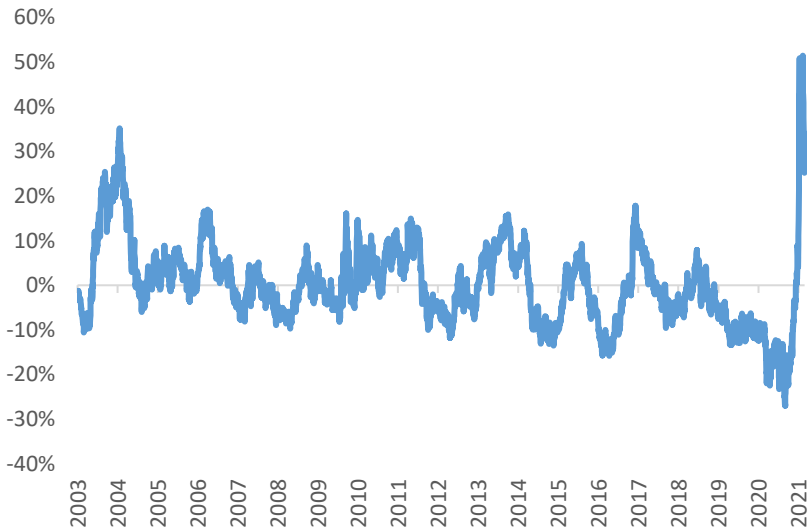
Broken record...yep, you guessed it...small caps won again in February, this time outperforming large caps by 333 basis points for the month (Russell 2000 vs. Russell 1000). That extends the winning streak to six months in a row and cumulative outperformance over that time of 2,991 basis points.

With that kind of outperformance, small caps must look really expensive versus large caps, right? Wrong. Valuations of small caps versus large caps are exactly in line with where they typically trade. So, where do we go from here? The market has a way of overshooting so we suspect there will be a few pauses along the way as small caps continue to flex their muscles. As a reminder, history shows that once small caps take a leadership role like this, they don't like to give it up for several years. Keep an eye on this exciting asset class!

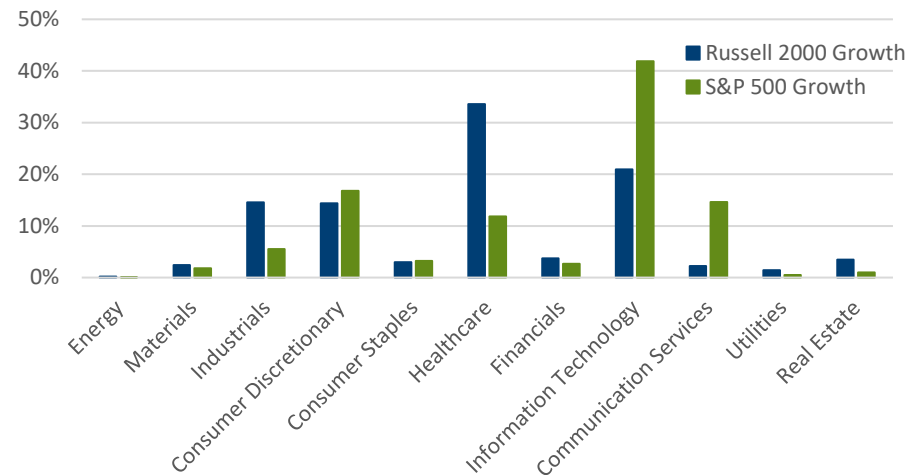

GICS SECTOR ALLOCATIONS (NET)



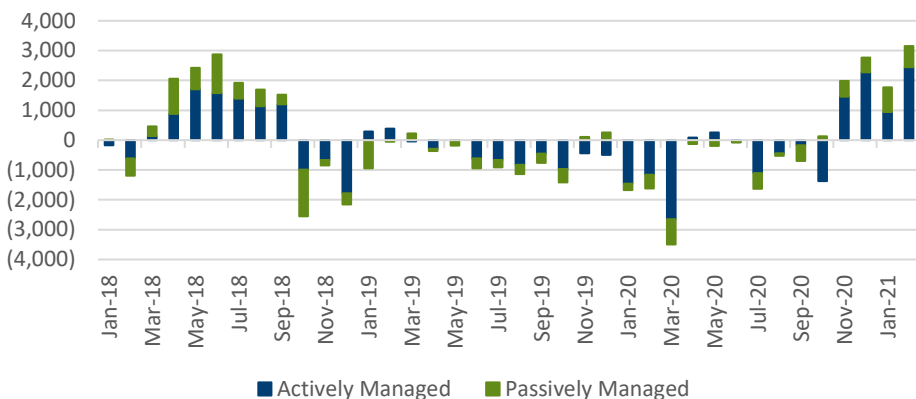

The **Russell 2000 Value Index** measures the performance of small-cap value segment of the US equity universe. It includes those Russell 2000 companies with lower price-to-book ratios and lower forecasted growth values. The **Russell Microcap Index** measures the performance of the microcap segment of the U.S. equity market. Microcap stocks make up less than 3% of the U.S. equity market (by market cap) and consist of the smallest 1,000 securities in the small-cap Russell 2000® Index, plus the next 1,000 smallest eligible securities by market cap. The **Russell Microcap Growth Index** measures the performance of the microcap growth segment of the U.S. equity market. It includes Russell Microcap companies that are considered more growth oriented relative to the overall market as defined by Russell's leading style methodology. The **Russell Microcap Value Index** measures the performance of the microcap value segment of the U.S. equity market. It includes Russell Microcap companies that are considered more value oriented relative to the overall market as defined by Russell's leading style methodology.

The **S&P 500 Growth Index** measures growth stocks using three factors: sales growth, the ratio of earnings change to price, and momentum. S&P Style Indices divide the complete market capitalization of each parent index into growth and value segments. Constituents are drawn from the S&P 500. **Standard deviation** is a measure of volatility. **Sharpe ratio** is a calculation that reflects the reward per each unit of risk in a portfolio. The higher the ratio, the better the portfolio's risk-adjusted return is.
