WHAT'S NEW

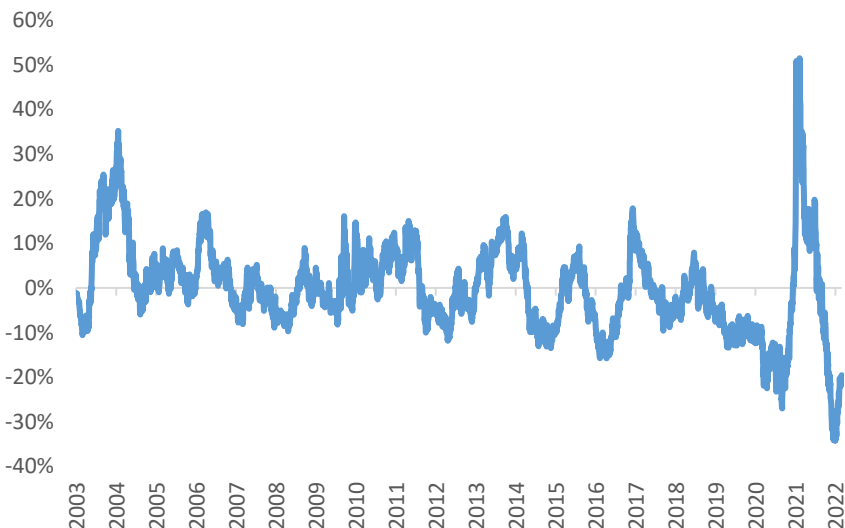
This might surprise you...Despite intensifying macro concerns, small caps gained during February and outperformed large caps by 381 basis points (Russell 2000 less Russell 1000). Why the outperformance? It might be because fundamentals remain strong and valuations got too cheap. Or, because the international economic and geopolitical picture is getting murkier by the day and small caps are nearly a pure play on the US economy. Or, because small caps entered a bear market in late January (down 20%+ from highs) and the VIX rose above 30 in late February, both of which have historically marked positive entry points for small cap investors.

Maybe all of the above played a role. One month does not make a trend, but this month's performance provides an intriguing data point—possibly the start of a trend.

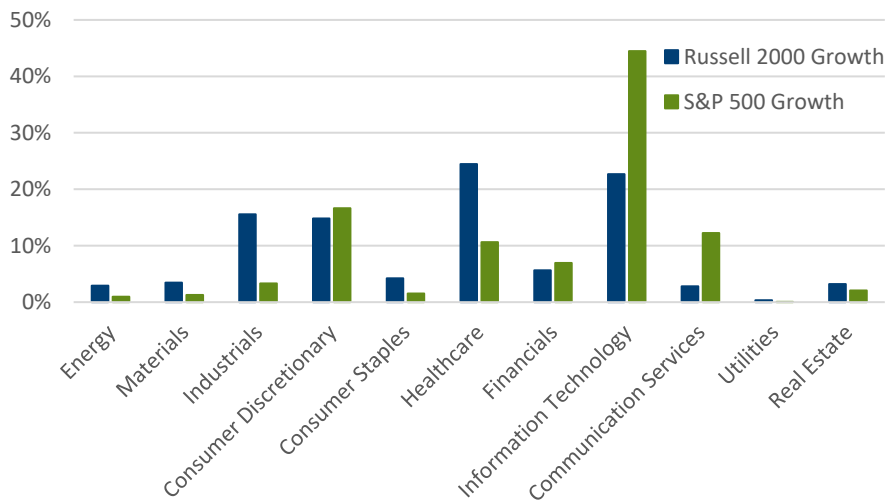

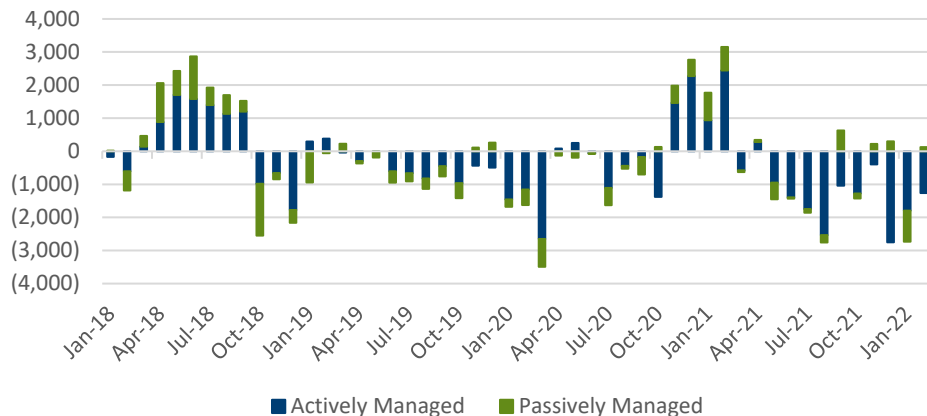

It includes those Russell 2000 companies with lower price-to-book ratios and lower forecasted growth values. The **Russell Microcap Index** measures the performance of the microcap segment of the US equity market. Microcap stocks make up less than 3% of the US equity market (by market cap) and consist of the smallest 1,000 securities in the small-cap Russell 2000® Index, plus the next 1,000 smallest eligible securities by market cap. The **Russell Microcap Growth Index** measures the performance of the microcap growth segment of the US equity market. It includes Russell Microcap companies that are considered more growth oriented relative to the overall market as defined by Russell's leading style methodology. The **Russell Microcap Value Index** measures the performance of the microcap value segment of the US equity market. It includes Russell Microcap companies that are considered more value oriented relative to the overall market as defined by Russell's leading style methodology.

The **S&P 500 Growth Index** measures growth stocks using three factors: sales growth, the ratio of earnings change to price, and momentum. S&P Style Indices divide the complete market capitalization of each parent index into growth and value segments. Constituents are drawn from the S&P 500. **Standard deviation** is a measure of volatility. **Sharpe ratio** is a calculation that reflects the reward per each unit of risk in a portfolio. The higher the ratio, the better the portfolio's risk-adjusted return is.
