WHAT'S NEW

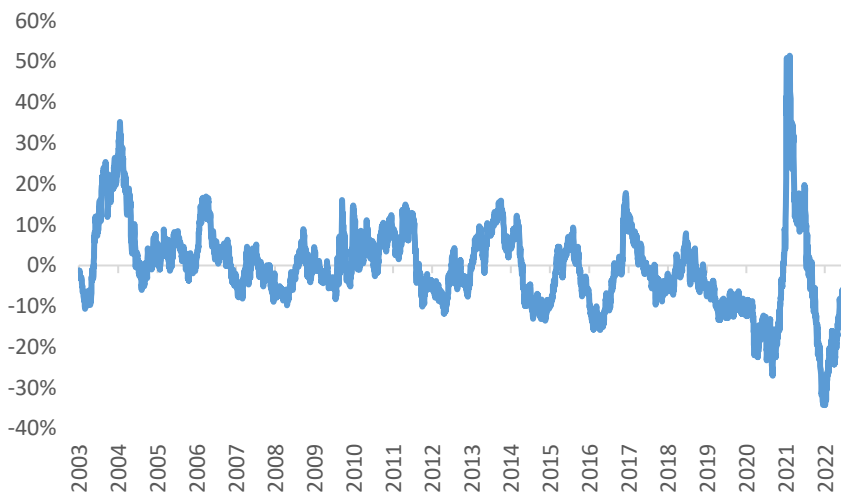
Another drop...Stocks fell in June, nearly matching the April destruction and continuing the YTD downward pattern of investment returns. This year's first-half performance for small caps is one of the worst on record. For the month, the Russell 2000 fell 8.22%, slightly outperforming the Russell 1000, which fell 8.38%.

In June, many commodity prices—including copper, wheat, and natural gas—rolled over meaningfully. This triggered recession fears and significant rotation out of cyclical value stocks and into growth and defensive stocks. The rotation happened for both large and small cap stocks. Within the small cap space, the Russell 2000 Growth fell by 6.19%, outperforming the Russell 2000 Value, which fell by 9.88%. Despite lagging in June, the Russell 2000 Value still ended the first half of the year 1,214 basis points ahead of the Russell 2000 Growth.

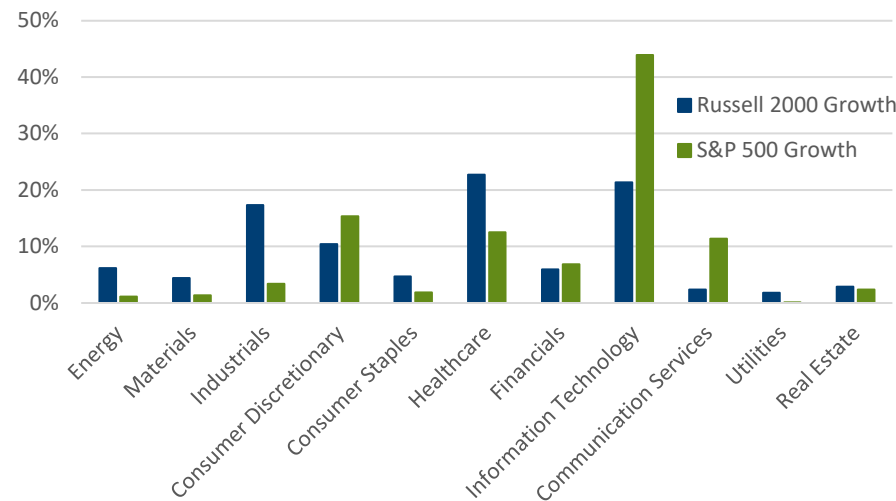

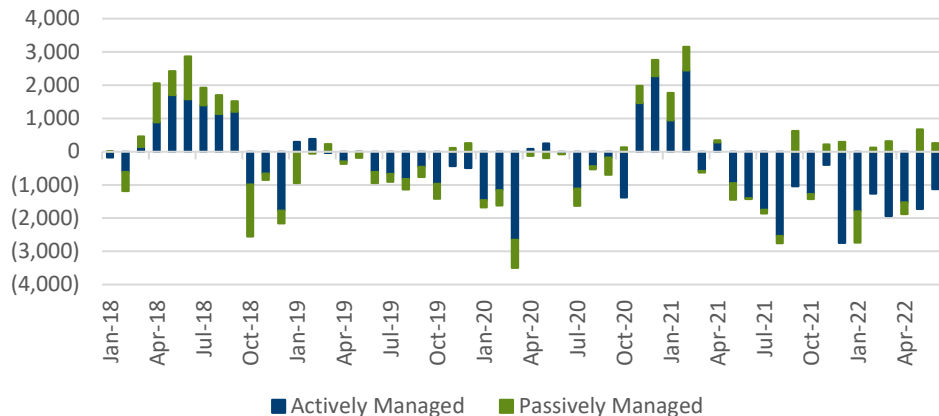

The **Russell 2000 Value Index** measures the performance of small-cap value segment of the US equity universe. It includes those Russell 2000 companies with lower price-to-book ratios and lower forecasted growth values. The **Russell Microcap Index** measures the performance of the microcap segment of the US equity market. Microcap stocks make up less than 3% of the US equity market (by market cap) and consist of the smallest 1,000 securities in the small-cap Russell 2000® Index, plus the next 1,000 smallest eligible securities by market cap. The **Russell Microcap Growth Index** measures the performance of the microcap growth segment of the US equity market. It includes Russell Microcap companies that are considered more growth oriented relative to the overall market as defined by Russell's leading style methodology. The **Russell Microcap Value Index** measures the performance of the microcap value segment of the US equity market. It includes Russell Microcap companies that are considered more value oriented relative to the overall market as defined by Russell's leading style methodology.

The **S&P 500 Growth Index** measures growth stocks using three factors: sales growth, the ratio of earnings change to price, and momentum. S&P Style Indices divide the complete market capitalization of each parent index into growth and value segments. Constituents are drawn from the S&P 500. **Standard deviation** is a measure of volatility. **Sharpe ratio** is a calculation that reflects the reward per each unit of risk in a portfolio. The higher the ratio, the better the portfolio's risk-adjusted return is.
