
#### **OVERVIEW**


March was an extremely volatile month with daily moves in the broad equity indices that were among some of the largest in history. Convertibles were not exempt from the sell-off as underlying equities were pressured while credit spreads widened simultaneously. Cyclical companies and those with high financial leverage were hit the hardest, but there were virtually no areas left unscathed as all sectors posted negative returns during the month.

The flipside is that such volatility can create opportunities as the seemingly indiscriminate selling pushed convertible theoretical valuations to discounts that we have rarely seen over the past few decades. Risks must continue to be actively managed, but these cheap converts coupled with a reset of both equity valuations and credit spreads have the potential to combine for particularly compelling returns going forward as fear subsides.





#### **VALUATION OF THE CONVERTIBLE MARKET**


JUNE 30, 1995 TO MARCH 31, 2020





# CONVERTIBLE MARKET COMPOSITION AS OF 3/31/20
