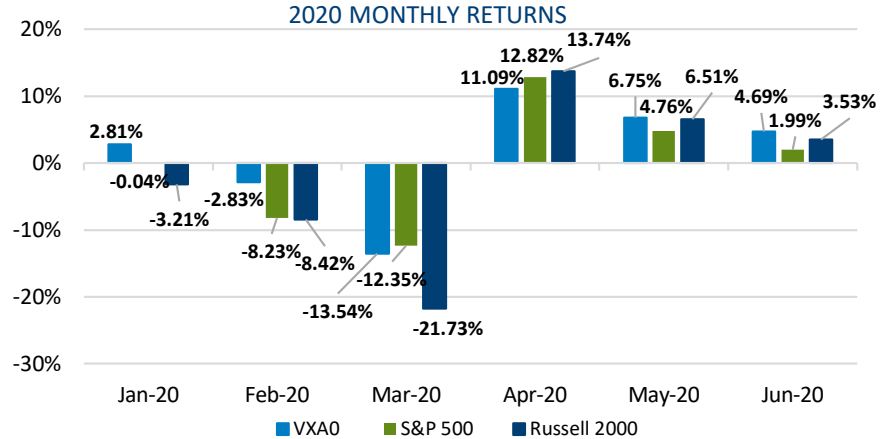
## OVERVIEW

June marked the halfway point in what has turned out to be a very eventful year for the convertible market. Another \$19 billion in domestic new issues priced during the month bringing the quarterly total to \$54 billion—an amount that by itself exceeds the annual totals seen in recent years. At the same time, investor demand for convertibles remained very strong as their unique hybrid characteristics once again demonstrated the ability to help navigate the near unprecedented volatility seen in the financial markets.

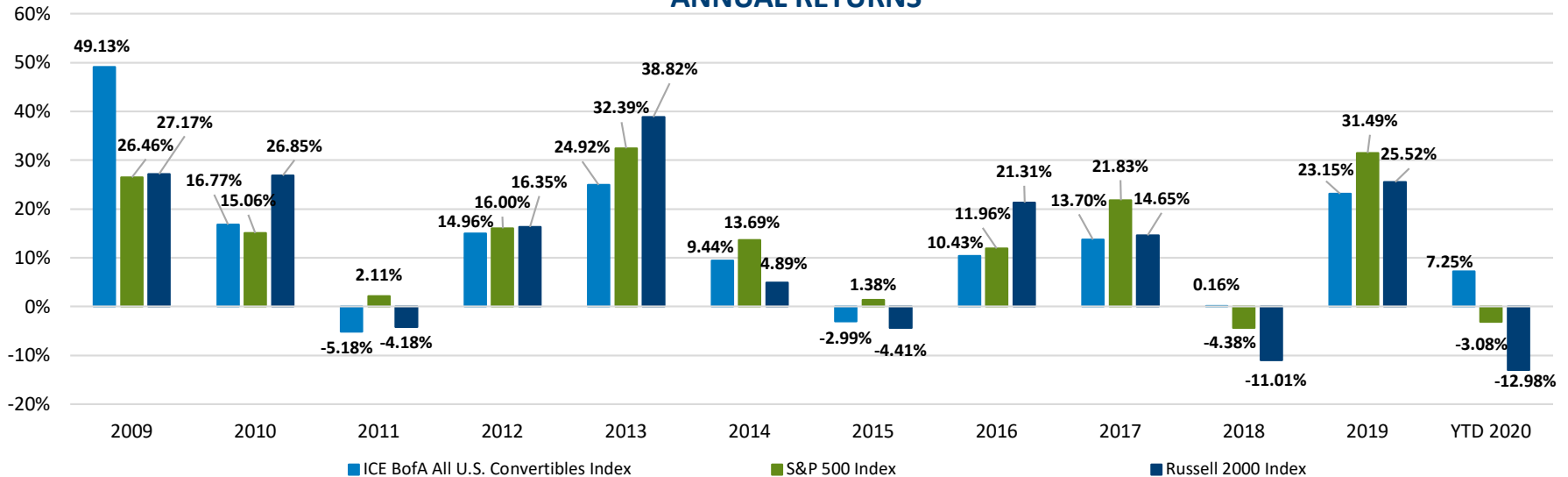
While it is likely that the pace of new issuance may decelerate in the summer months, we continue to expect that convertibles will remain a preferred option for companies looking to access capital in these uncertain times. Looking forward, the convert market remains quite healthy and the expansion of the market this year helps broaden the opportunity set resulting in ample opportunities for active management in the pursuit of enhancing returns while managing risk.

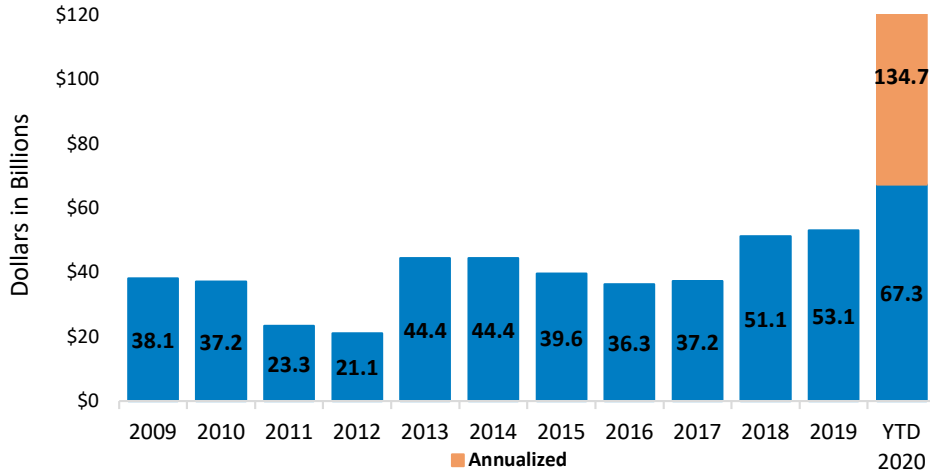
## ANNUAL RETURNS



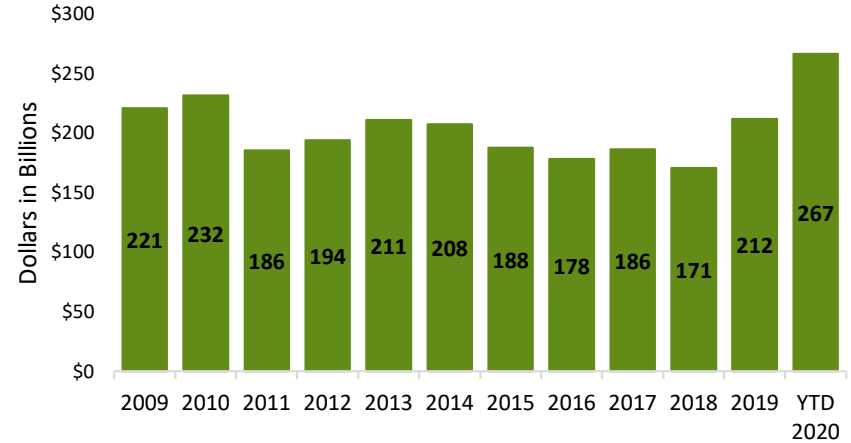

# U.S. Convertible Market ISSUANCE



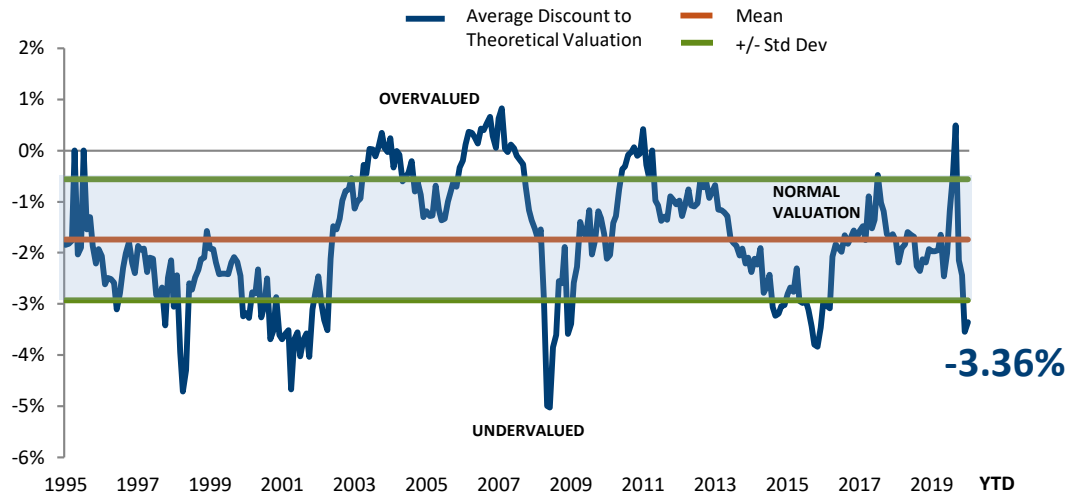

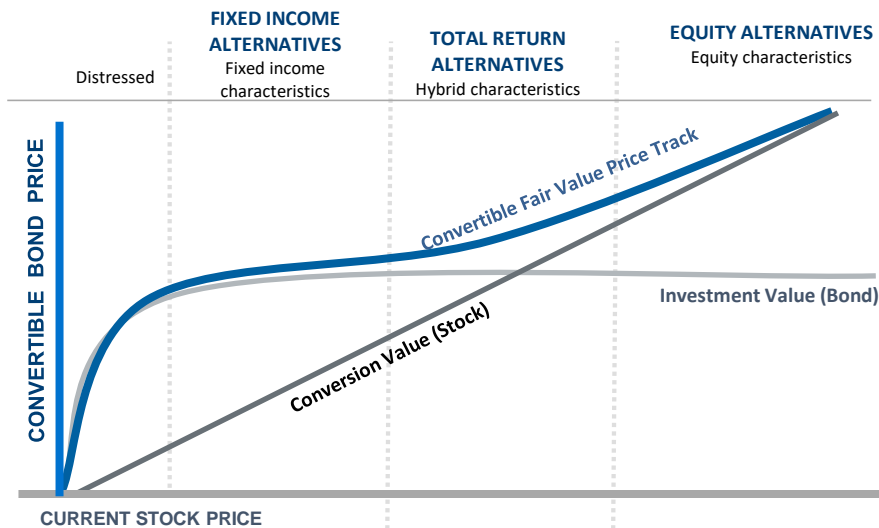
# VALUATION OF THE CONVERTIBLE MARKET

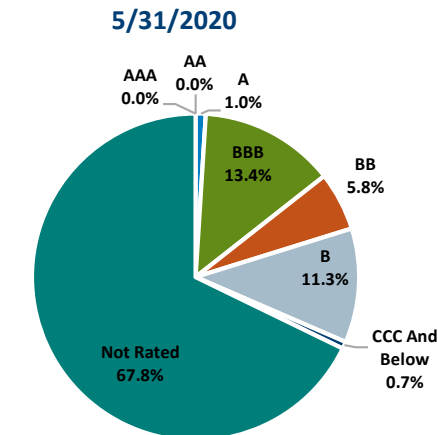
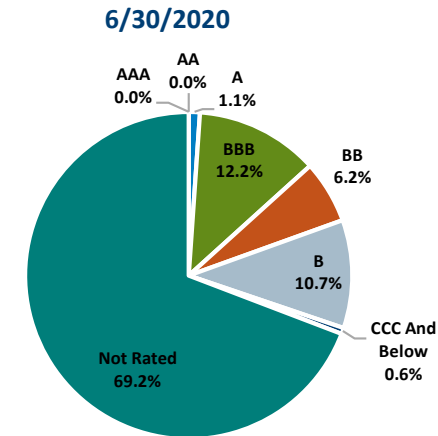
