OVERVIEW

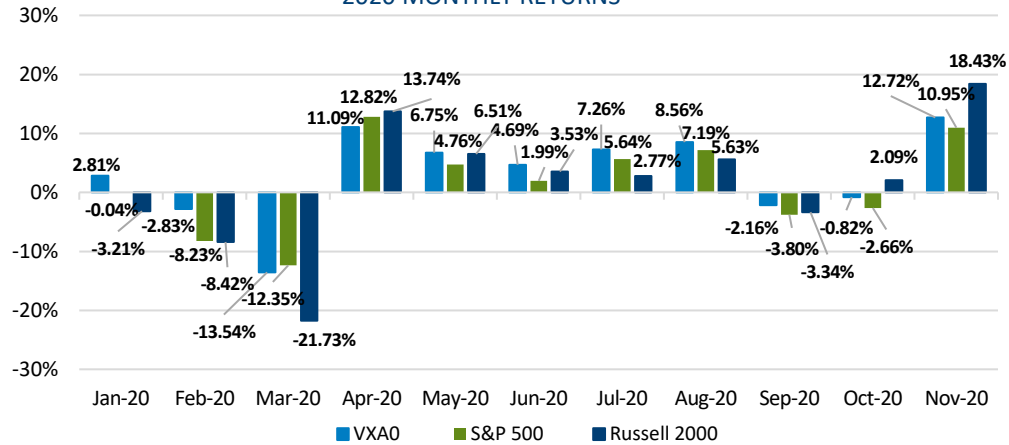

November was a very strong month for risk assets. Convertibles were one of the best performing asset classes driven by broad-based strength as every sector posted positive returns with particularly strong gains from the IT and Consumer sector. Equity-sensitive convertibles gained the most during the month, but balanced convertibles also appreciated a healthy 11% and matched the double-digit returns posted by many broader equity indices.

New issuance accelerated with \$6 billion in the U.S., \$14.5 billion globally, and resulted in one of the strongest November months we've had in recent years. This new issuance continues to help broaden out the issuer base and introduce new balanced converts to a market where rising equity prices, in some areas, has increased the equity sensitivity of existing convertibles. It has been a remarkable year for convertibles from many perspectives, and we continue to look forward to the opportunities ahead.

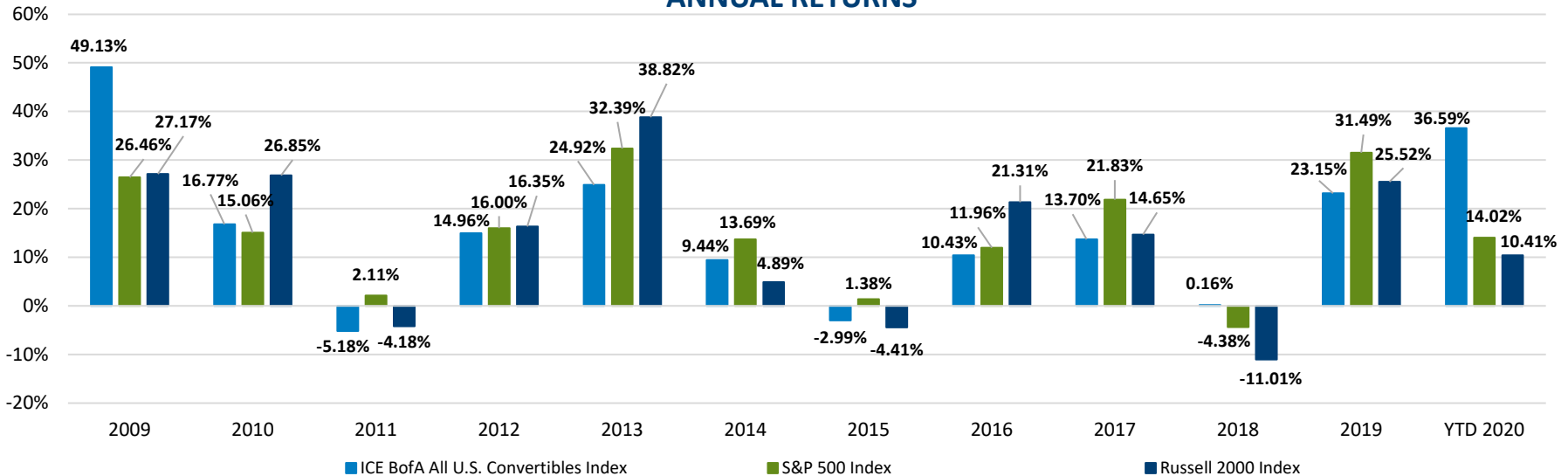
VXA0 vs. S&P 500 vs. RUSSELL 2000

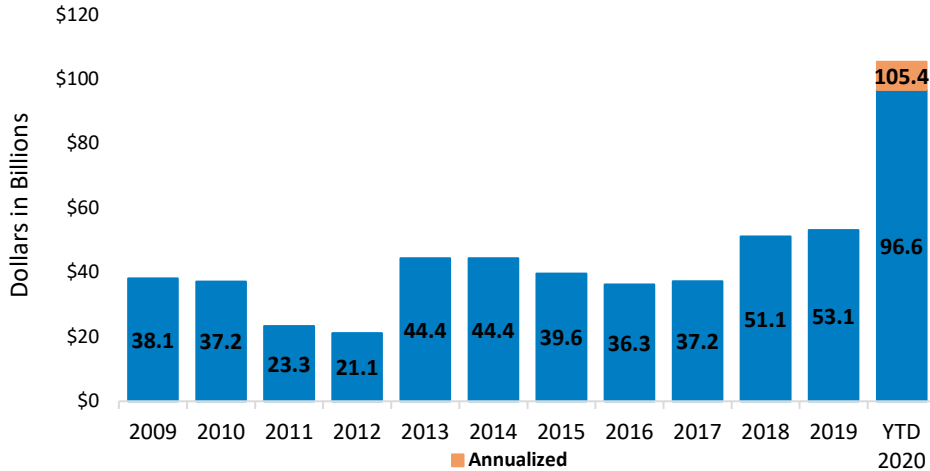
ANNUAL RETURNS



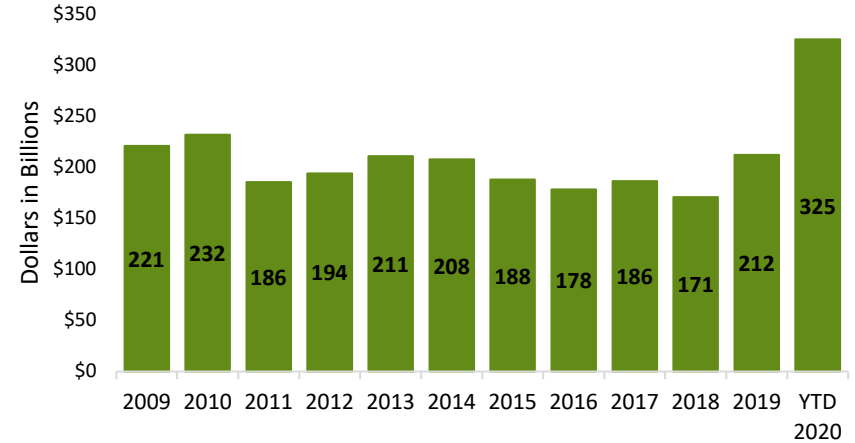

U.S. Convertible Market ISSUANCE



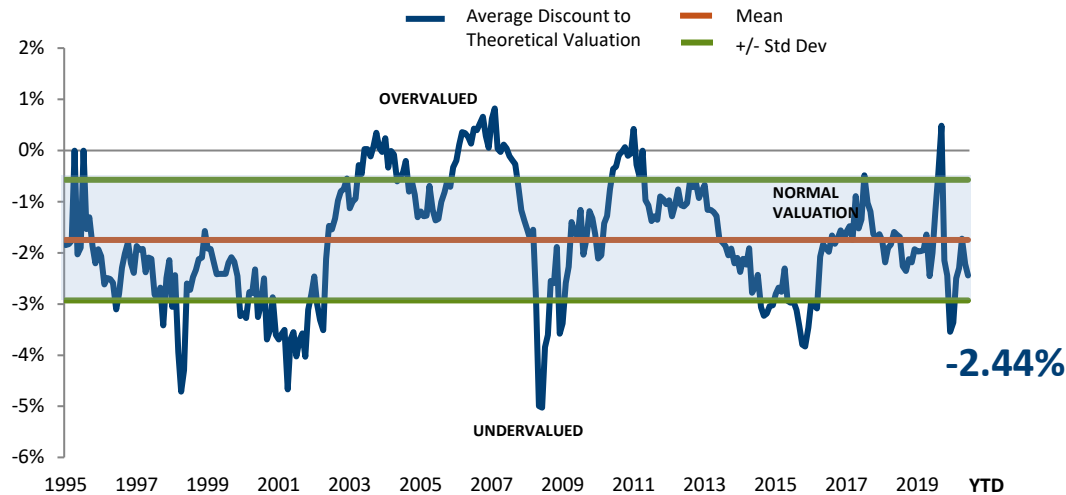

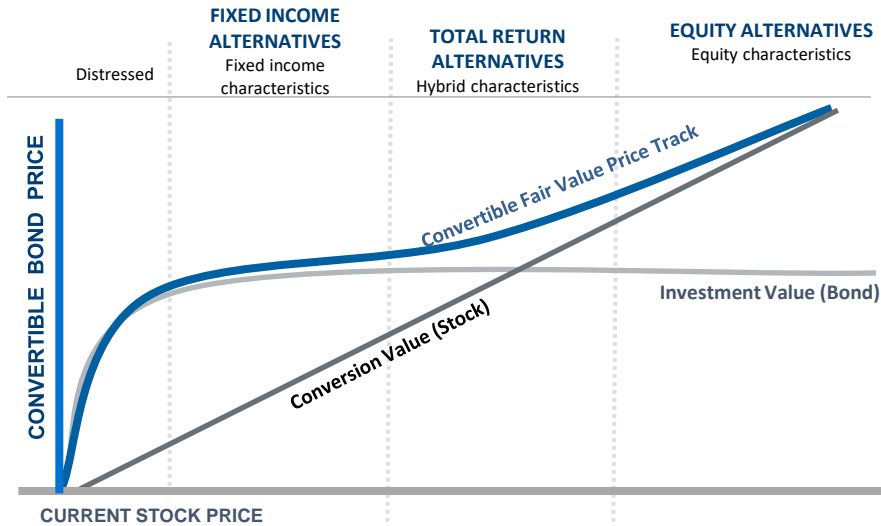
VALUATION OF THE CONVERTIBLE MARKET

CONVERTIBLE MARKET COMPOSITION AS OF 11/30/20

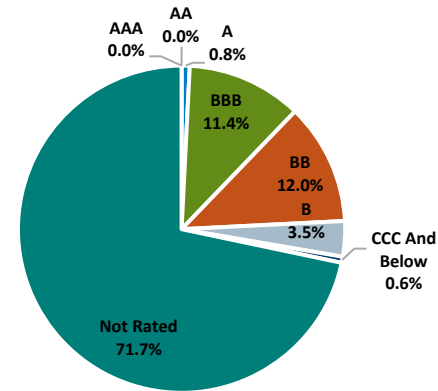

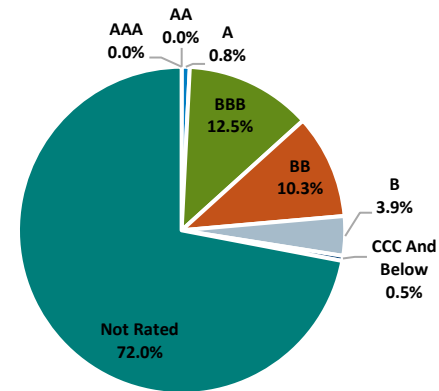
