OVERVIEW

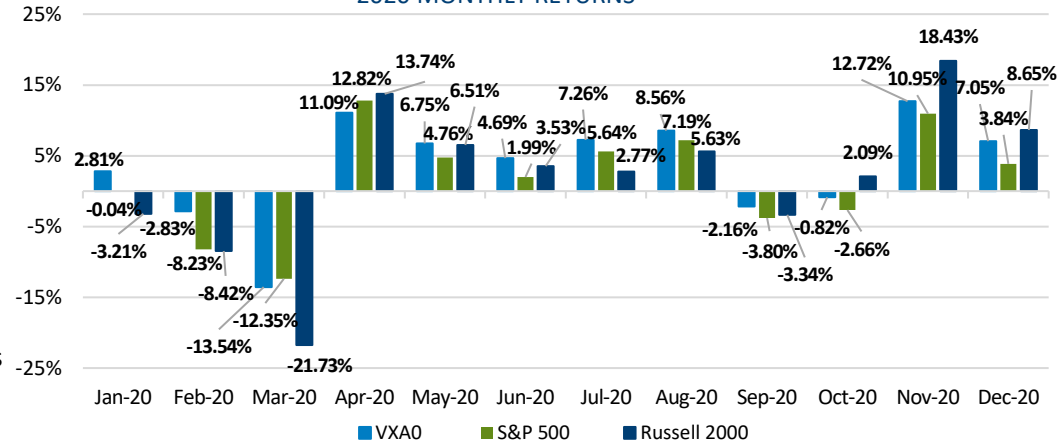

December was a strong finish to a remarkable year for the convertible market. Monthly new issuance continued above trend and brought the YTD total to \$158 billion globally and \$106 billion in the U.S., both near record highs. Continued appreciation of underlying equities drove further upside in converts with broad strength as every sector posted positive total returns for the month.

Last year as a whole produced unprecedented challenges to the global economy and financial markets. However, through all the uncertainty convertibles once again demonstrated their effectiveness as a strategic allocation by protecting on the downside and participating on the upside. As we look forward, we see many opportunities, but we also see the potential for continued volatility as we transition to a post-COVID world. We believe that an actively managed convertible strategy can be a beneficial tool in pursuing further equity upside participation with less equity risk.

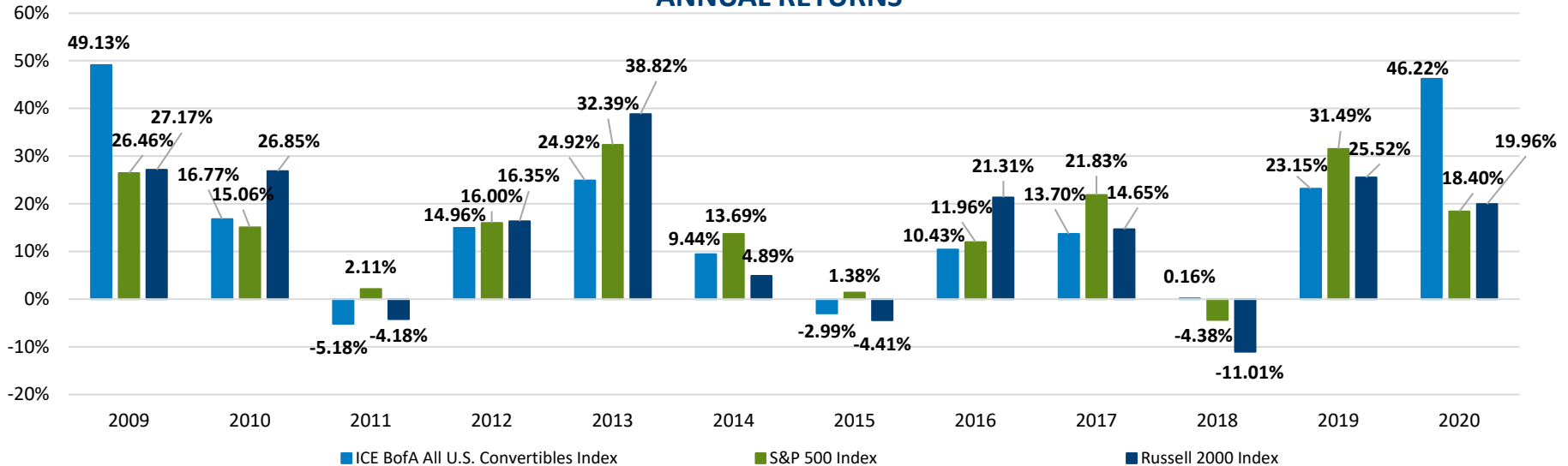
VXA0 vs. S&P 500 vs. RUSSELL 2000

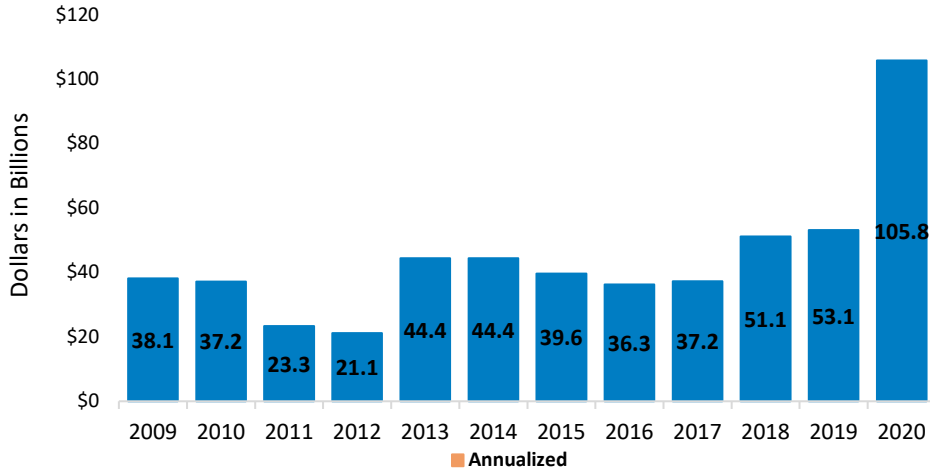
ANNUAL RETURNS



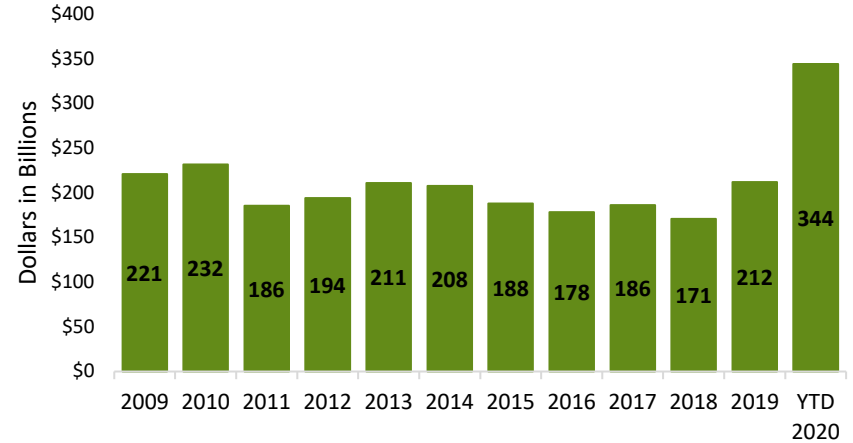

U.S. Convertible Market ISSUANCE



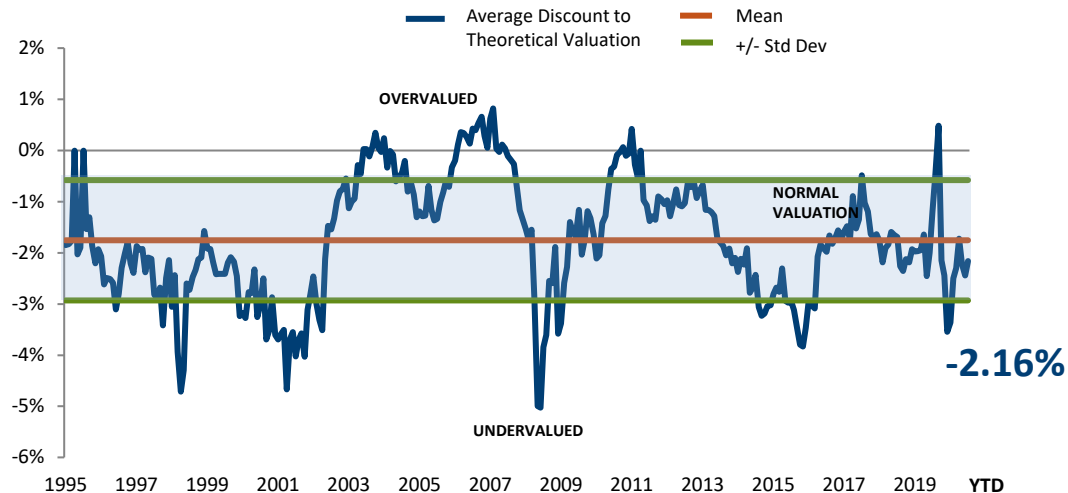

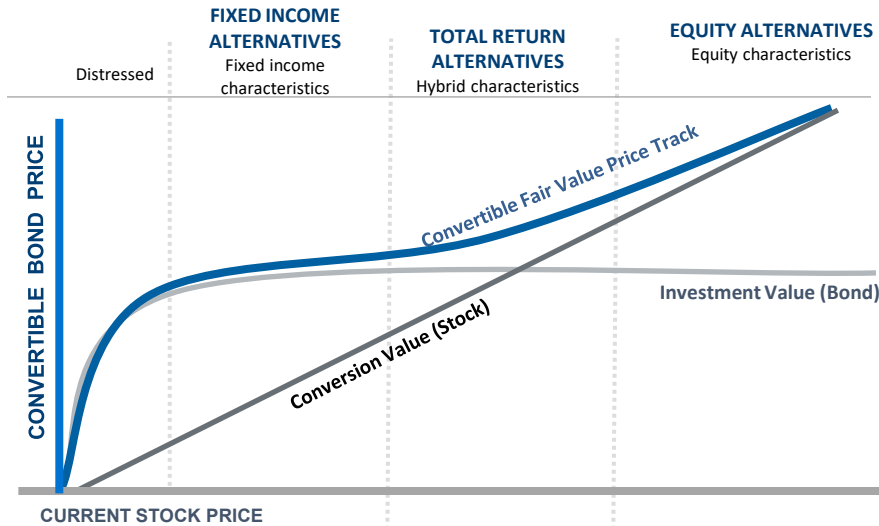
VALUATION OF THE CONVERTIBLE MARKET

CONVERTIBLE MARKET COMPOSITION AS OF 12/31/20

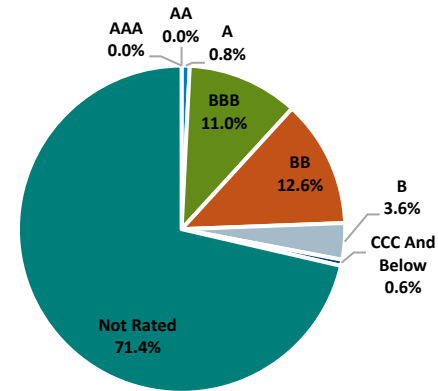

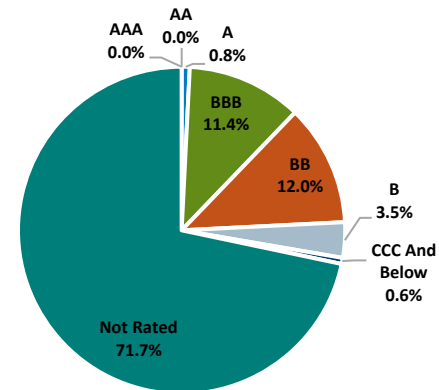

Investment Premium is the amount that the market price of the convertible is above its investment value, expressed as a percent of the investment value.
