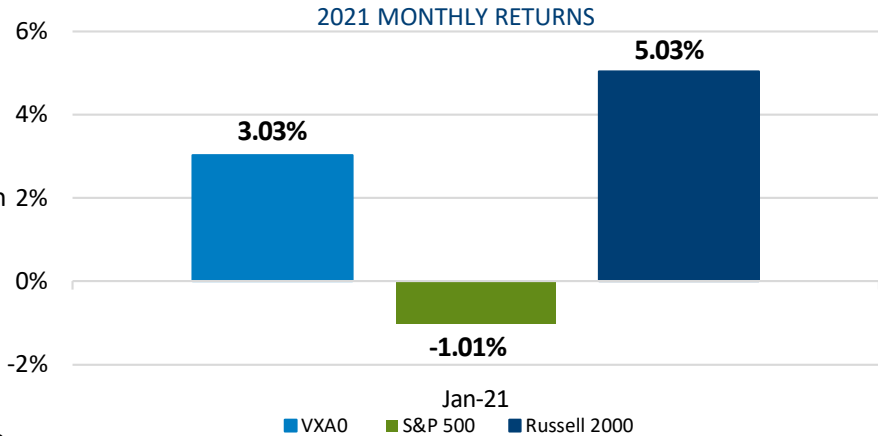
OVERVIEW

January presented a unique start to the year as outsized moves in a handful of stocks dominated market headlines and the uncertainty resulted in a headwind for risk assets late in the month. Despite this volatility, convertibles posted positive returns, with the equity-sensitive portion delivering most of the gains. New issues continued at a brisk pace with more than \$5 billion of deals pricing in the U.S. and \$13 billion around the globe—both ahead of typical January totals.

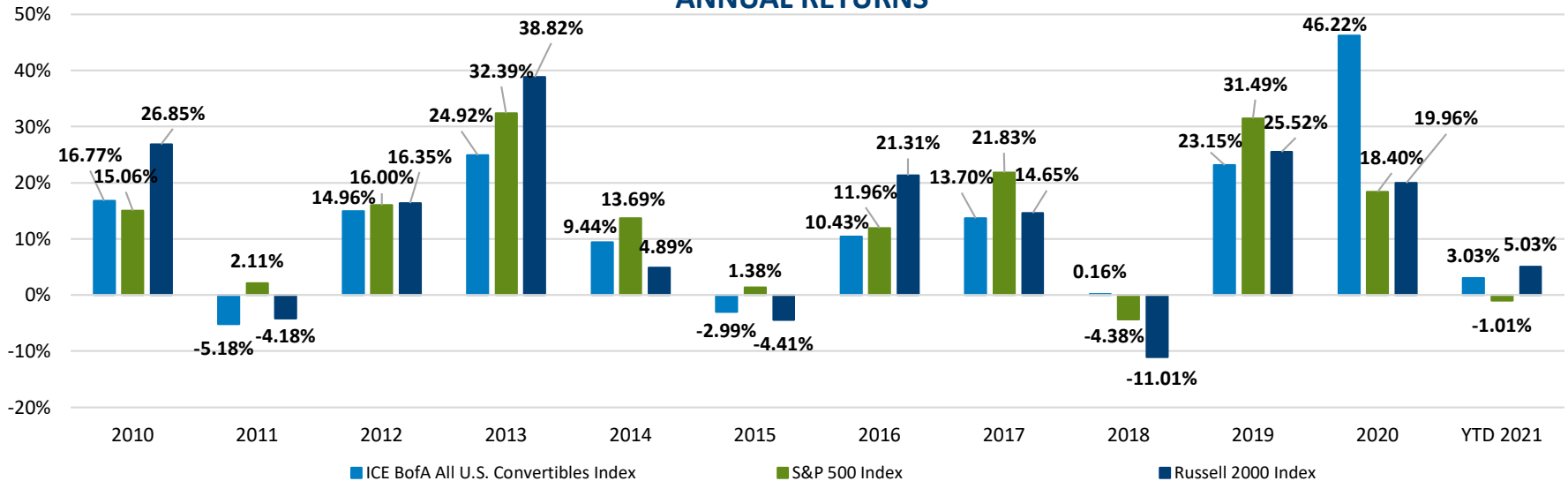
We continue to be encouraged by the prospect for further convertible new issuance and think these new balanced profiles can be a useful tool to help actively manage risk/reward within an overall convert market that has seen its equity sensitivity rise over the past few months. While market volatility may be getting headlines now, we expect the focus to return to company earnings reports over the next few weeks. That should shift the narrative from short term trading back to the positive trends of longer term fundamentals.

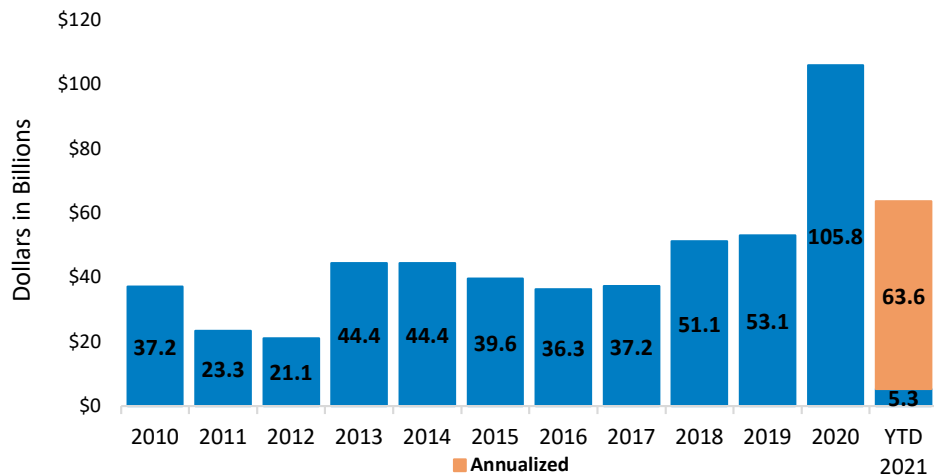
ANNUAL RETURNS



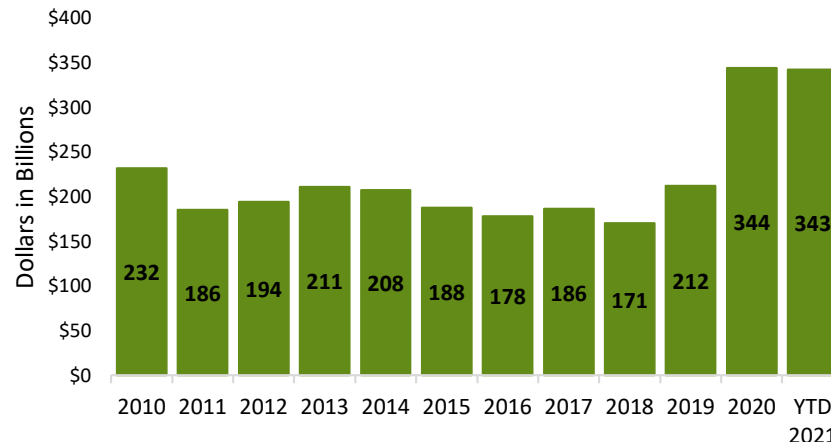

U.S. Convertible Market ISSUANCE



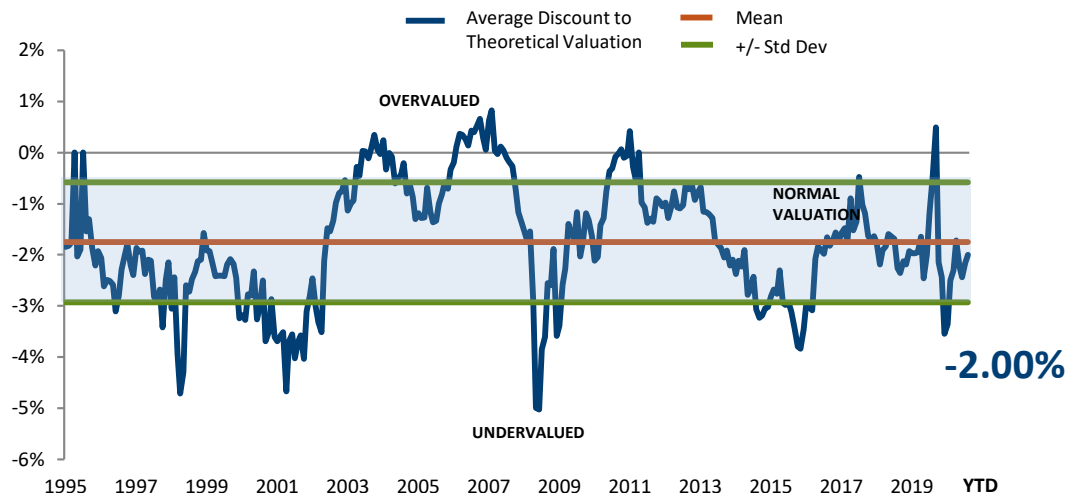

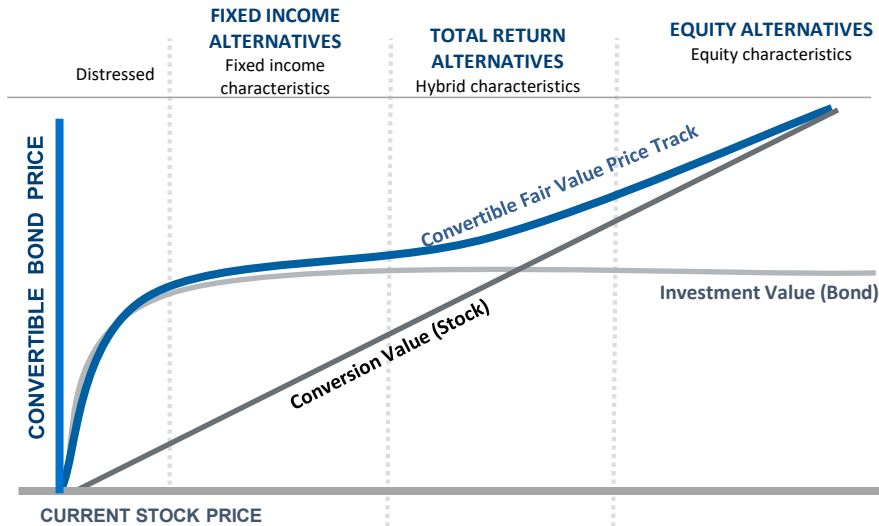
VALUATION OF THE CONVERTIBLE MARKET

CONVERTIBLE MARKET COMPOSITION AS OF 1/31/21

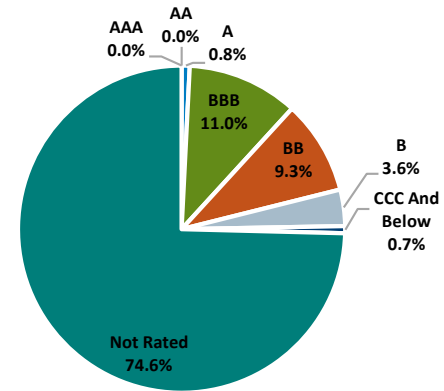

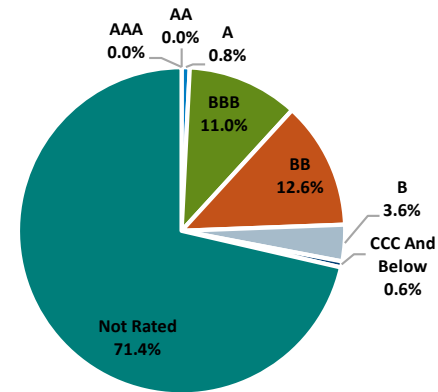
