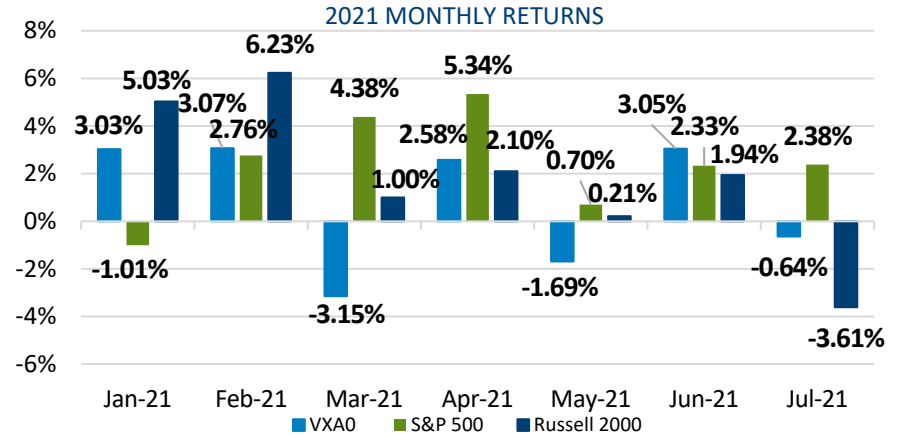
OVERVIEW

Convertible new issuance took a breather in July with slightly more than \$3 billion in new paper being brought to market globally. This seasonal slowdown is typical, with the combination of earnings reports and slower summer months tending to result in reduced deal activity. Despite that, year-to-date issuance trends remain favorable, and we anticipate a resumption in normal activity for the remainder of the year.

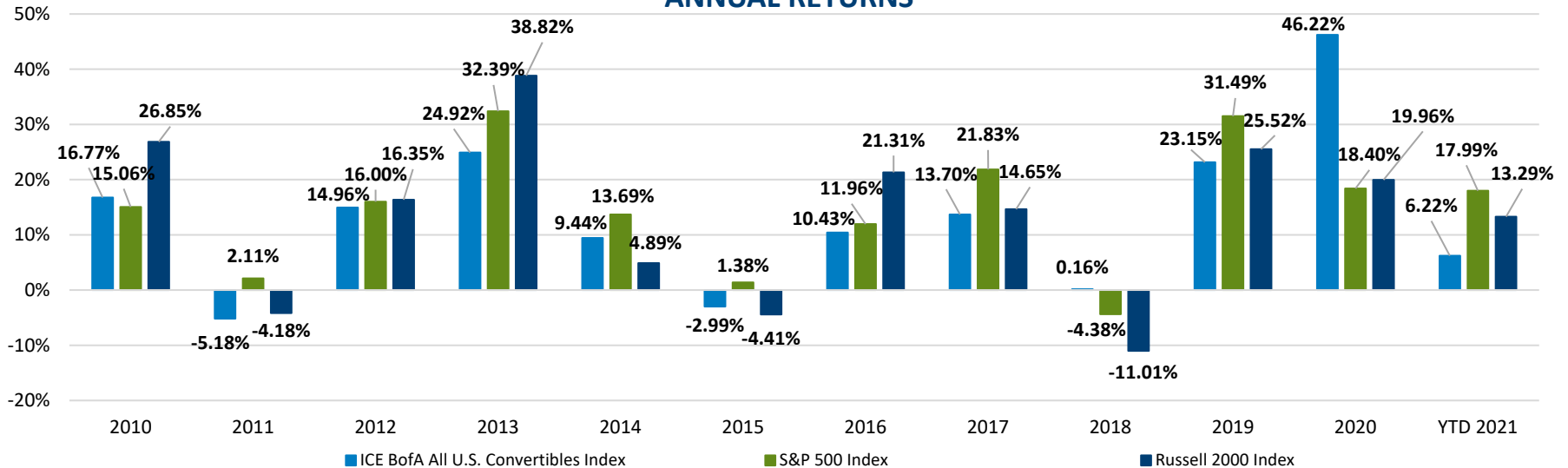
Also noteworthy was the volatility in the Asian convertible market during the month. Many underlying equities of convertible issuers experienced sharp declines as new regulations targeting the Chinese technology and education system were announced. The U.S. convert market mostly avoided this volatility and is now the top performing region on a year-to-date basis. Overall, we continue to see a healthy convertible market and believe that an active approach will continue to be beneficial in managing risks in these rapidly changing markets where volatility is likely to remain elevated.

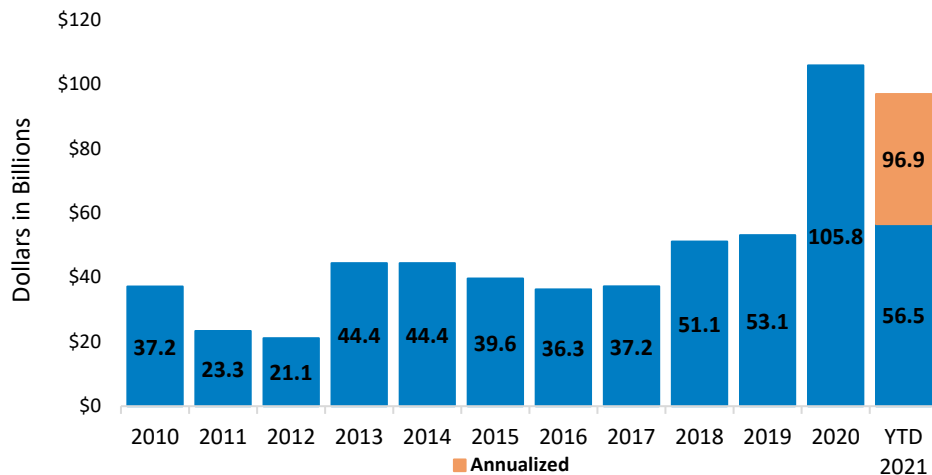
ANNUAL RETURNS



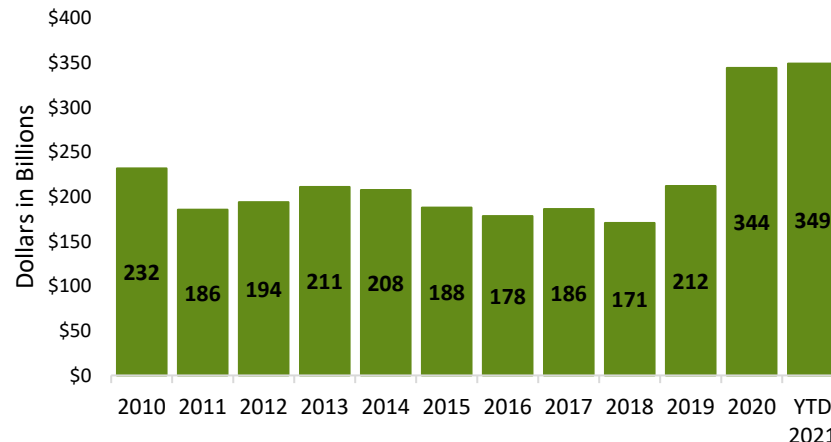

U.S. Convertible Market ISSUANCE



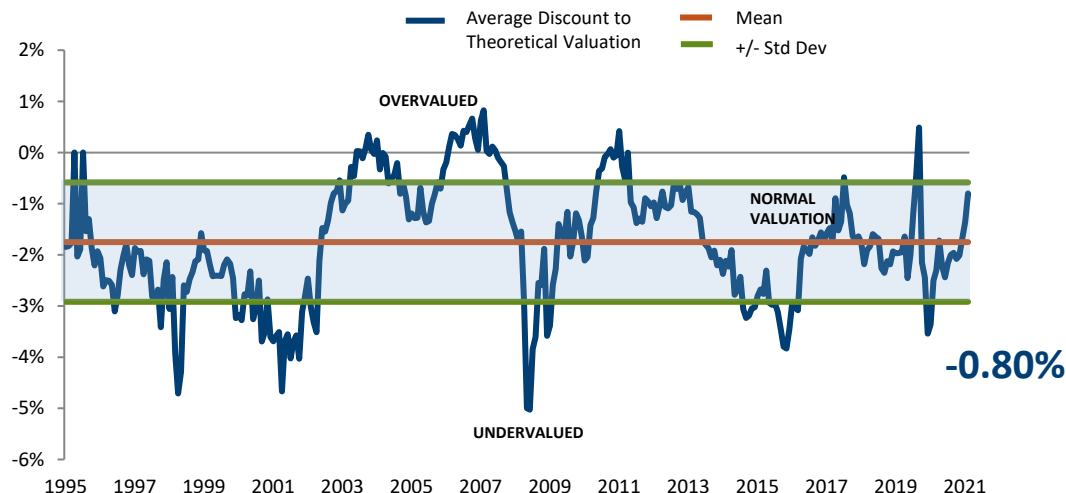

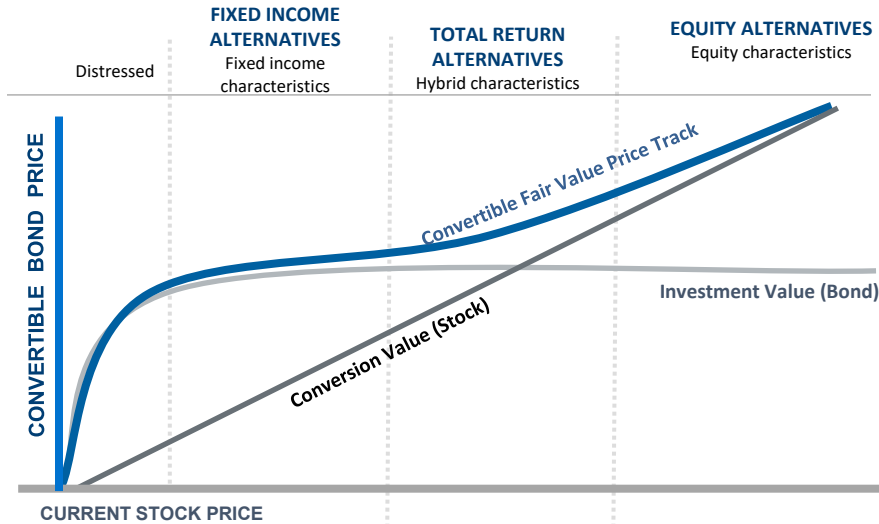
VALUATION OF THE CONVERTIBLE MARKET

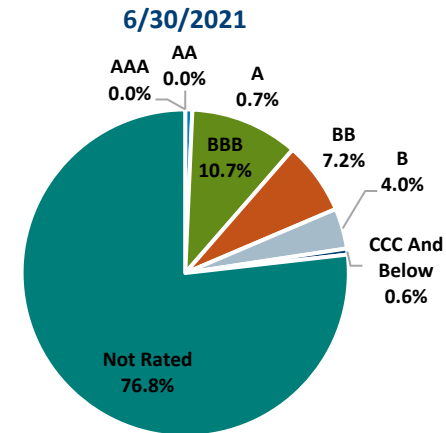
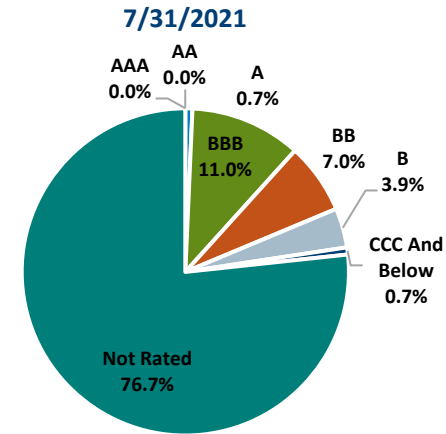
