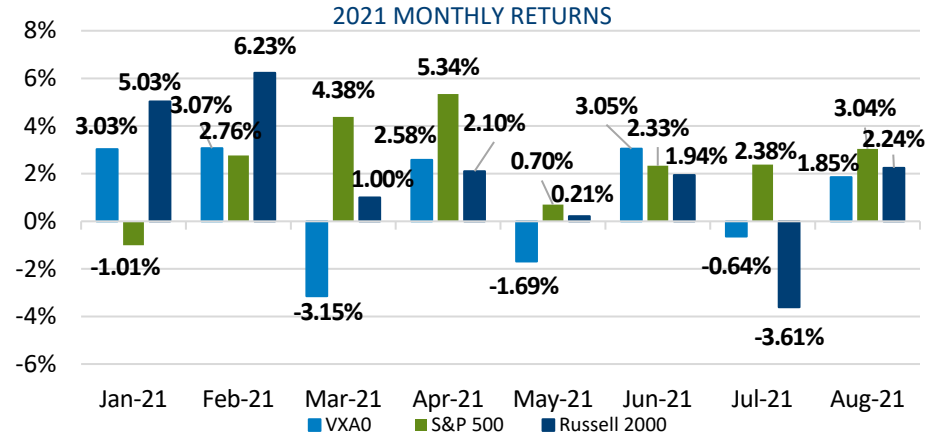
OVERVIEW

August was a solid month for the convertible market. U.S. convertibles appreciated 1.9% driven by strength in both secular and cyclical trends found within the Technology and Consumer Discretionary sectors. Equity-sensitive convertibles also outperformed and benefitted from a high degree of participation to the underlying equities of several issuers that posted upbeat earnings reports during the month.

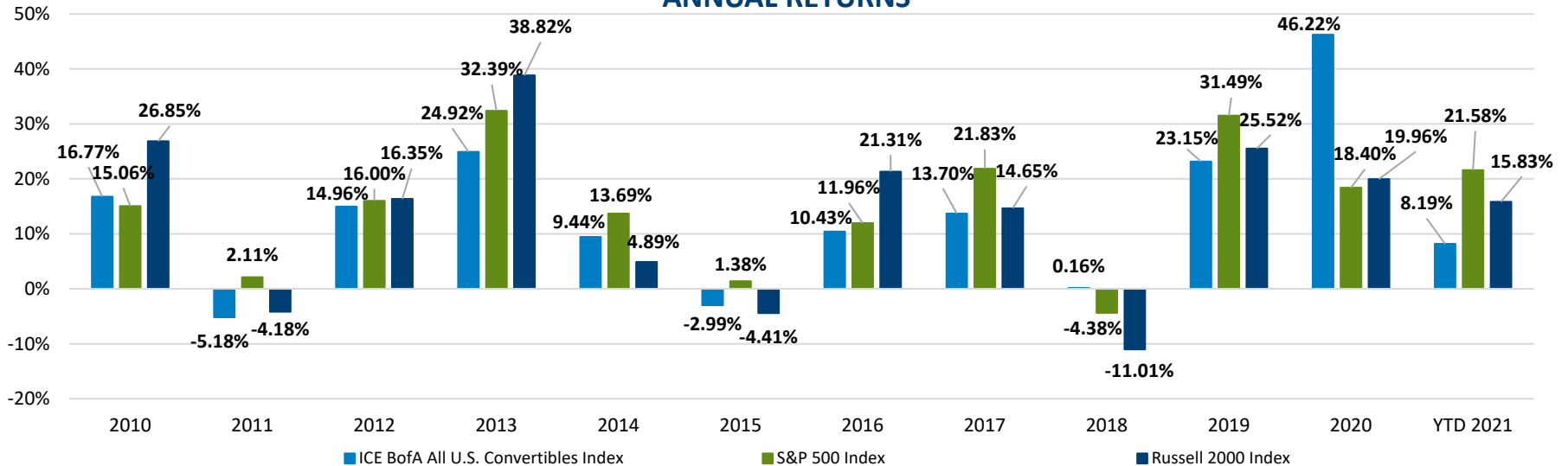
New issuance activity picked up with \$7 billion in deals coming to market globally, \$6 billion from the U.S. Year-to-date new issuance continues strong at \$109 billion, and we expect an active calendar for the remainder of the year. The convertible market remains quite healthy, in our view, and we continue to believe convertible securities are a compelling alternative to seek further equity upside participation while also managing downside risk.

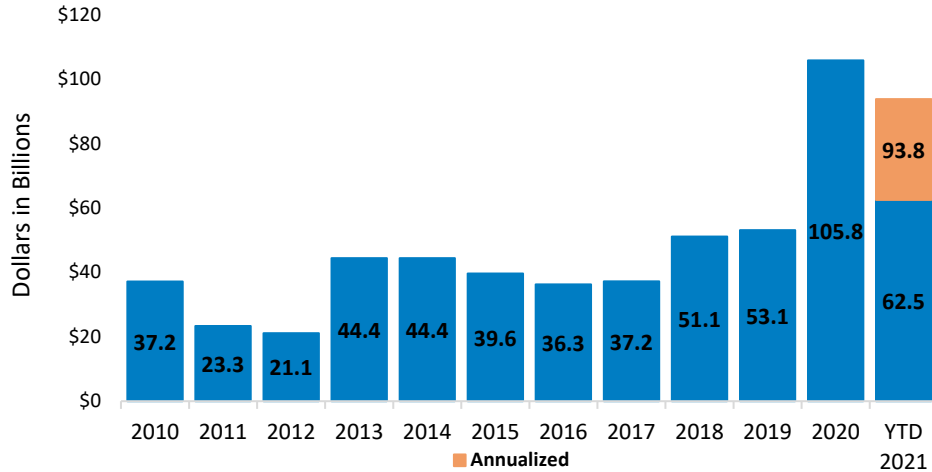
ANNUAL RETURNS



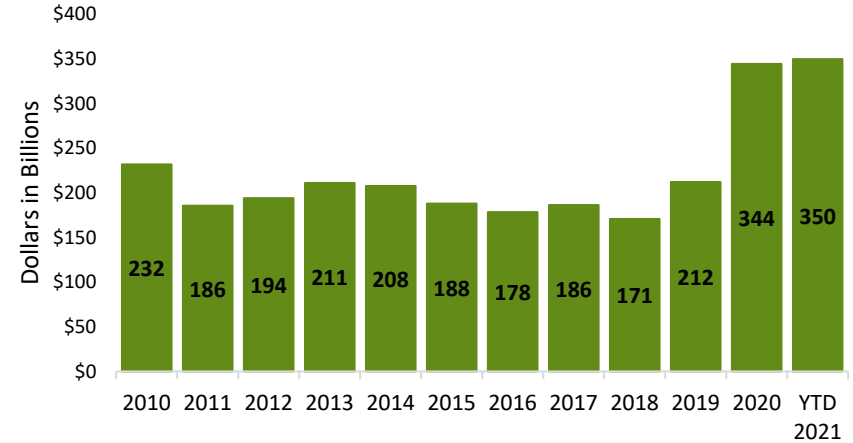

U.S. Convertible Market ISSUANCE



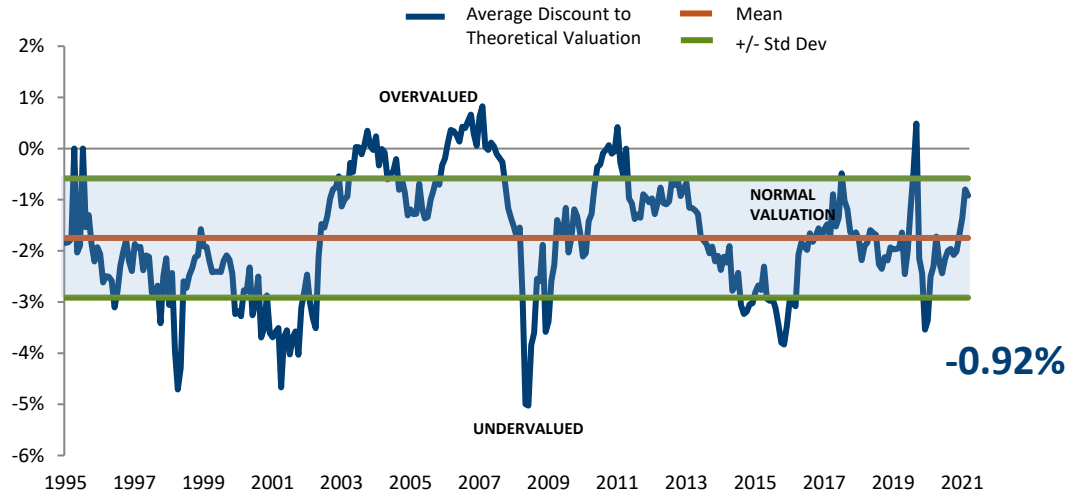

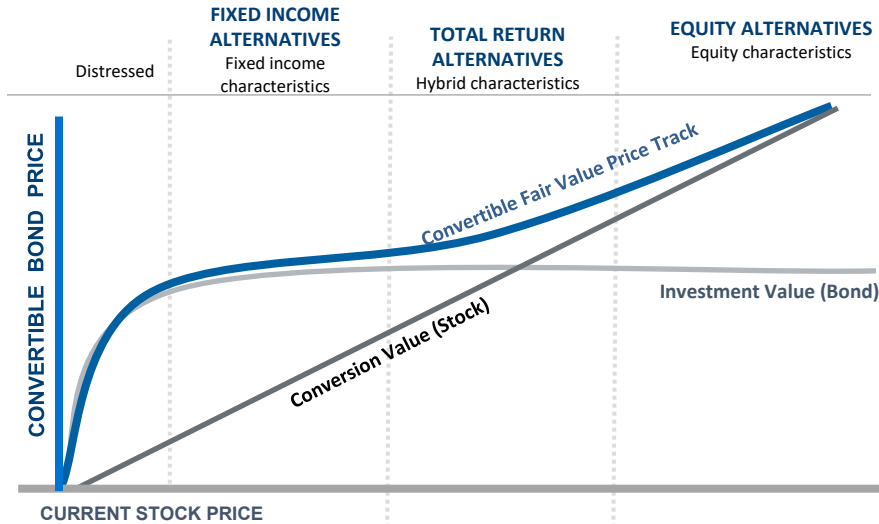
VALUATION OF THE CONVERTIBLE MARKET

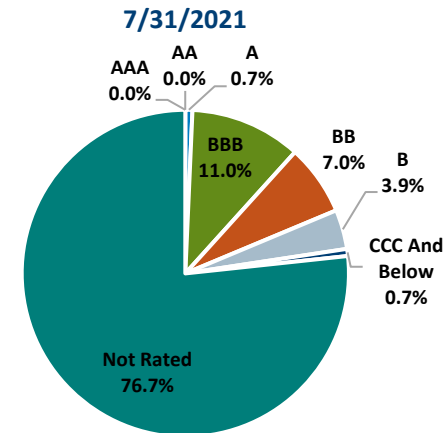
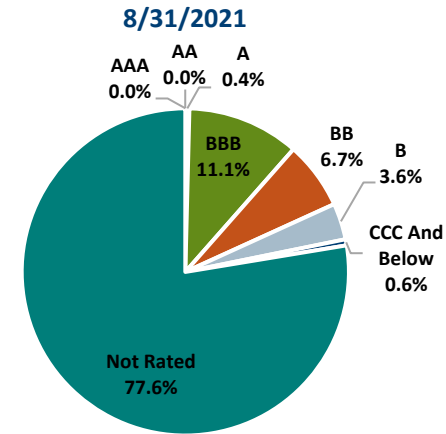
