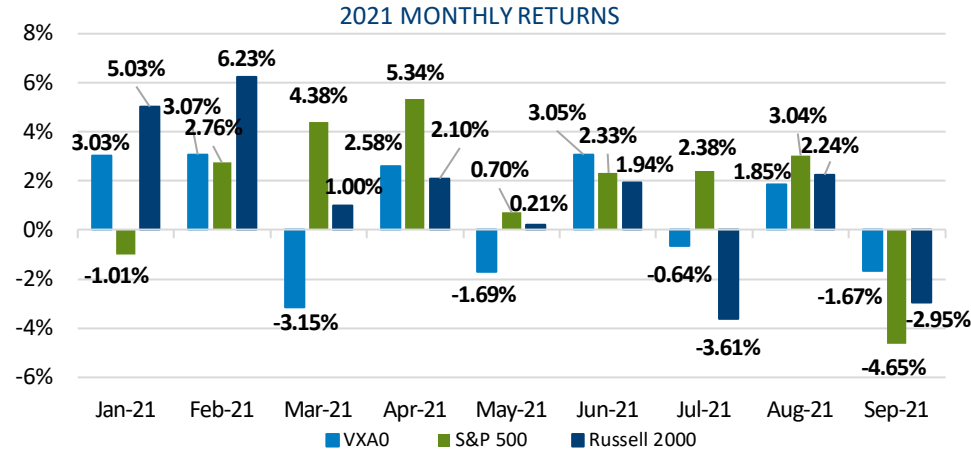
OVERVIEW

Risk assets paused in September as markets digest the implications of the 10-year Treasury yield crossing above 1.5% following the latest FOMC meeting. Convertibles proved to be resilient against this backdrop and participated in only a fraction of the broader S&P 500 near 5% decline. Both defensive and balanced convertibles outperformed the more equity-sensitive portions of the market.

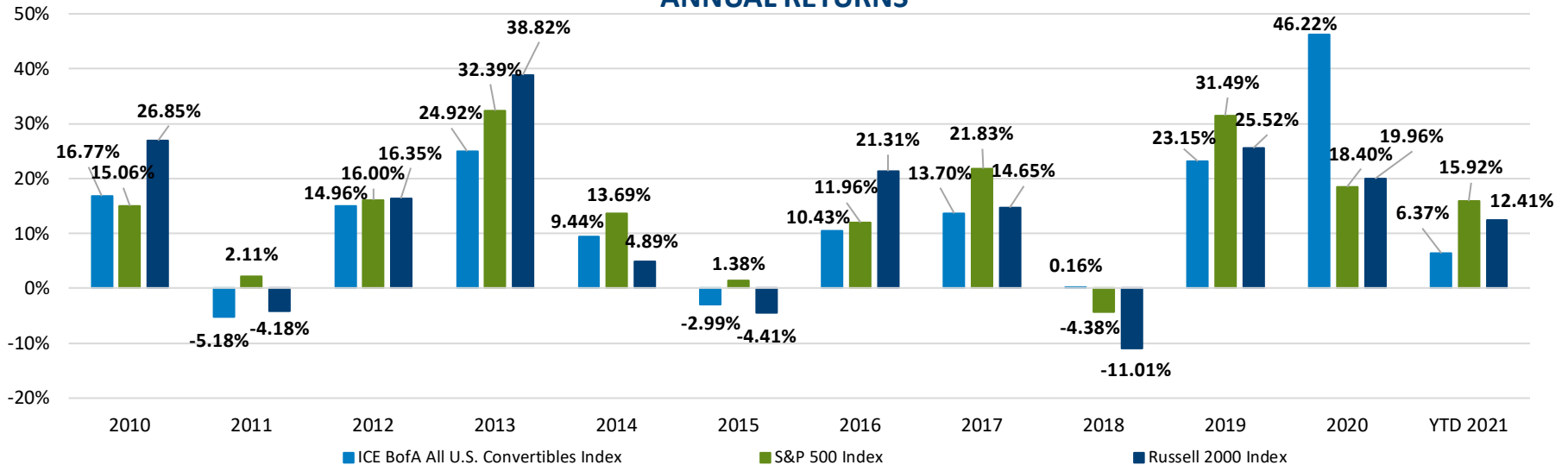
New issuance resumed with \$14 billion in deals pricing globally, \$6 billion of which came from the US. This activity continues to benefit the overall convert market by providing more opportunities to actively manage the structural risk/reward of a convertible portfolio. Looking forward, we continue to see a healthy mix of new and existing convertibles that provide an attractive opportunity set to help navigate short-term volatility and position portfolios to seek further potential upside in equities while also managing downside risk.

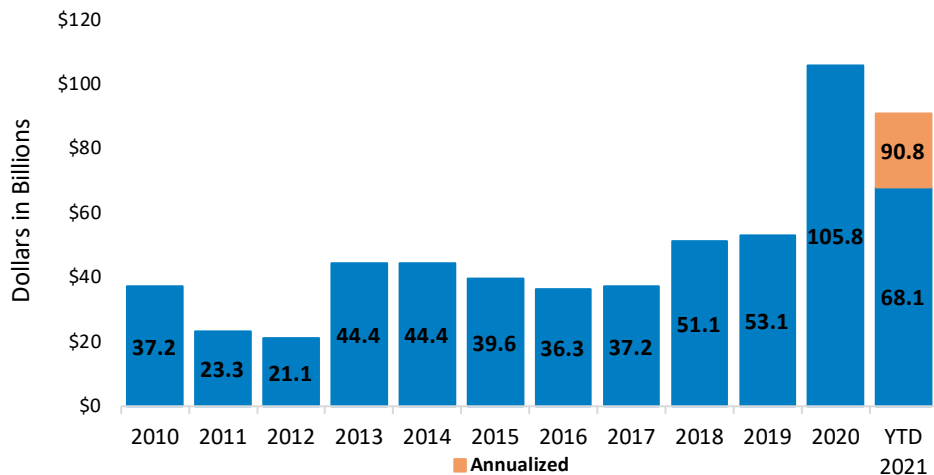
ANNUAL RETURNS



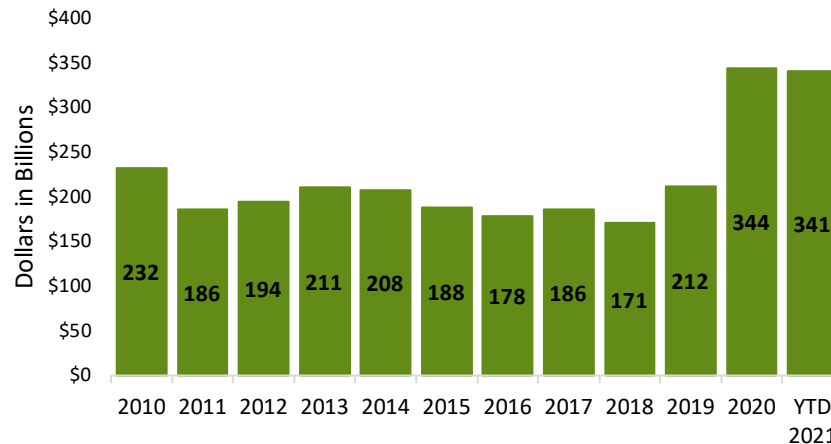

U.S. Convertible Market ISSUANCE



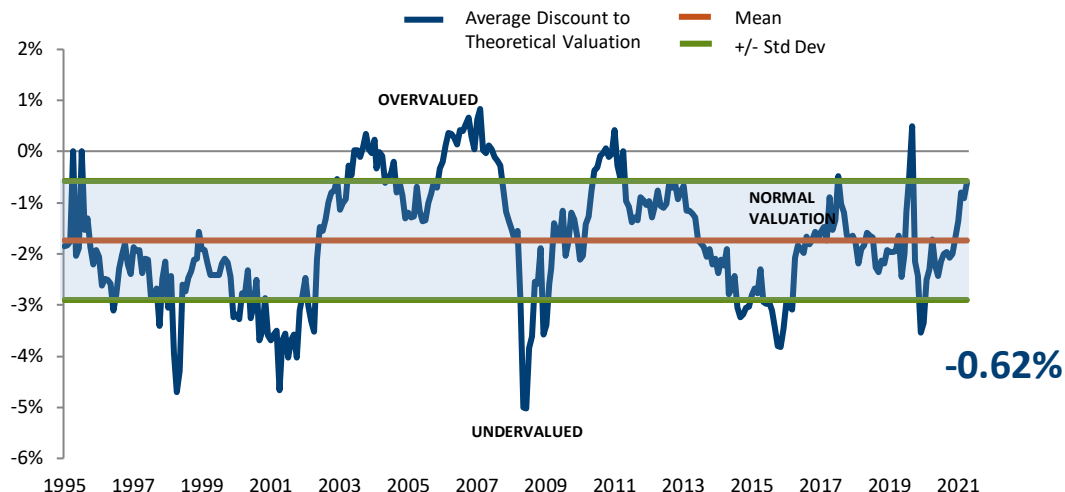

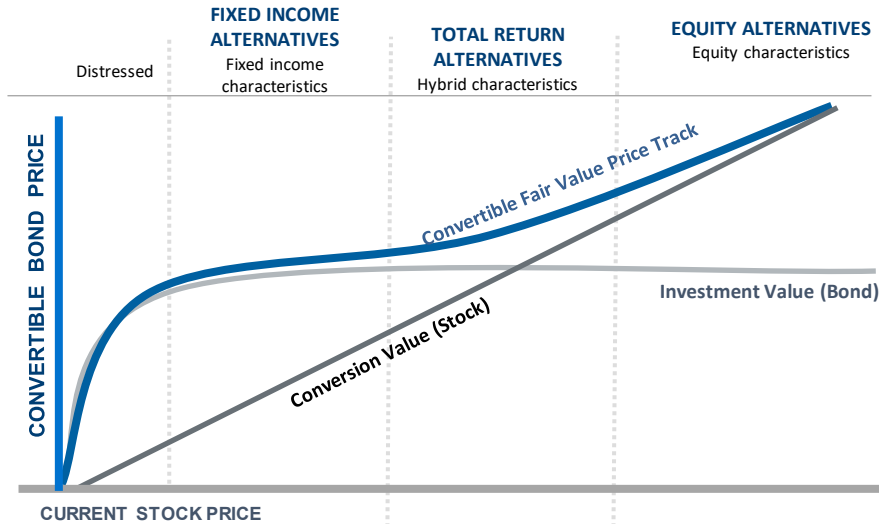
VALUATION OF THE CONVERTIBLE MARKET

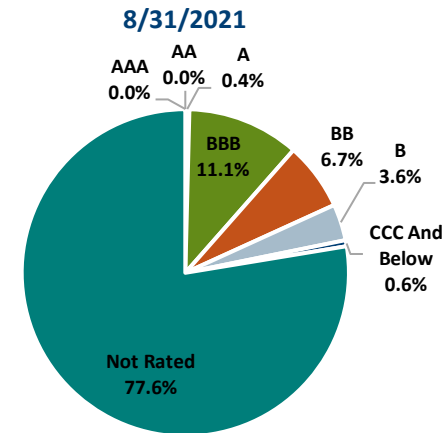
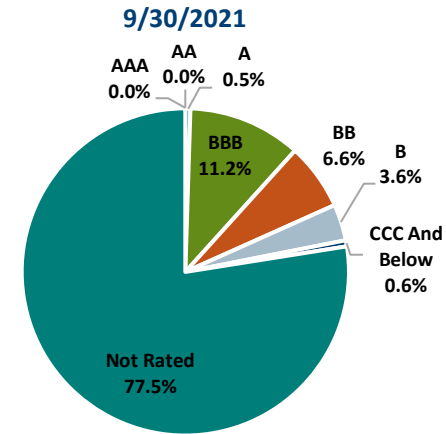
