## OVERVIEW

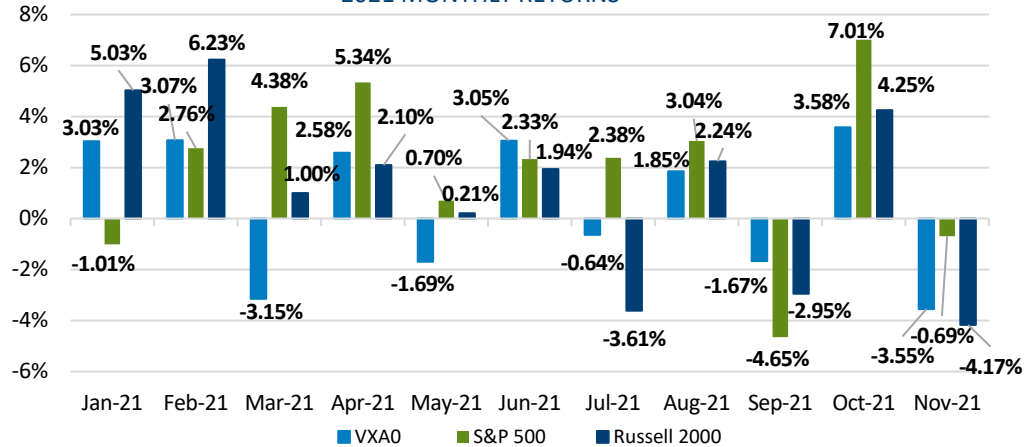

Convertibles pulled back during a busy month of November. Uncertainty surrounding the impacts of Federal Reserve tapering and the rising omicron Covid variant weighed heavily on the underlying stocks of convertible issuers. The credit side of convertibles held up well, which helped cushion the downside relative to their underlying stocks, but the difficult equity backdrop resulted in each economic sector posting a negative total return for the month.

New issuance resumed with \$16 billion in global deals coming to market during the month, \$10 billion of which came from the US. This brings the year-to-date total to \$141 billion. The convertible market remains well balanced, however, the pullback during the month shifted the overall equity sensitivity toward the lower end of its post-Covid range. Actively managing convertible risk/reward profiles through rotations like we have seen this year can help take advantage of future opportunities generated by the volatility.

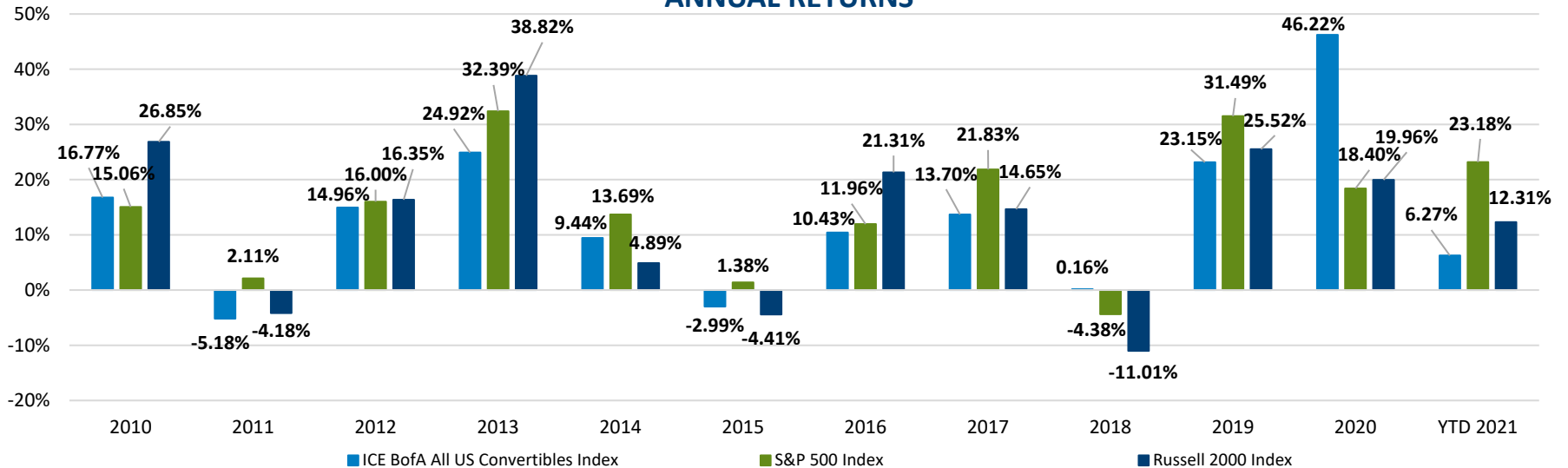
## VXAO vs. S&P 500 vs. RUSSELL 2000

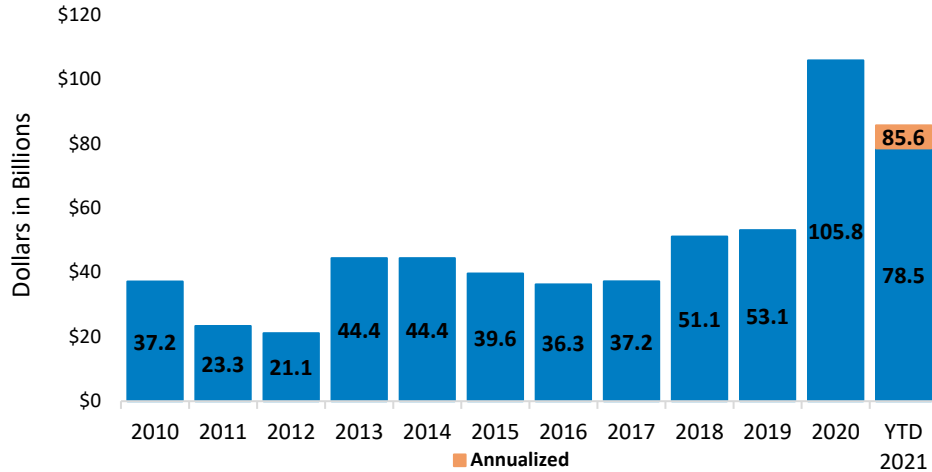
## ANNUAL RETURNS



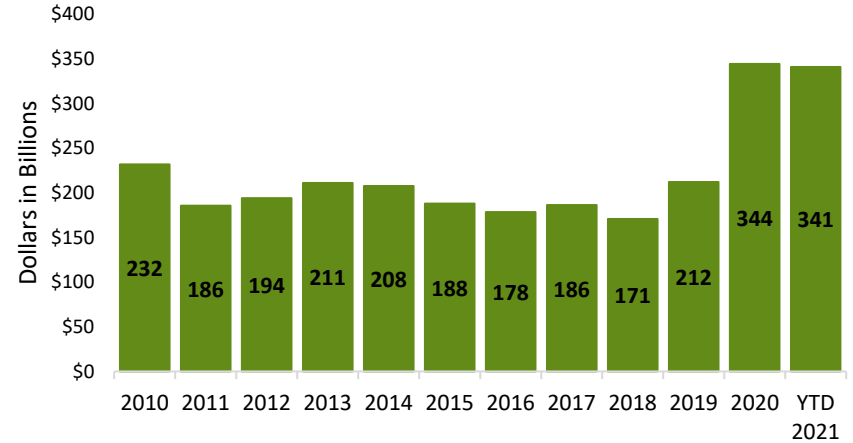

# US Convertible Market ISSUANCE



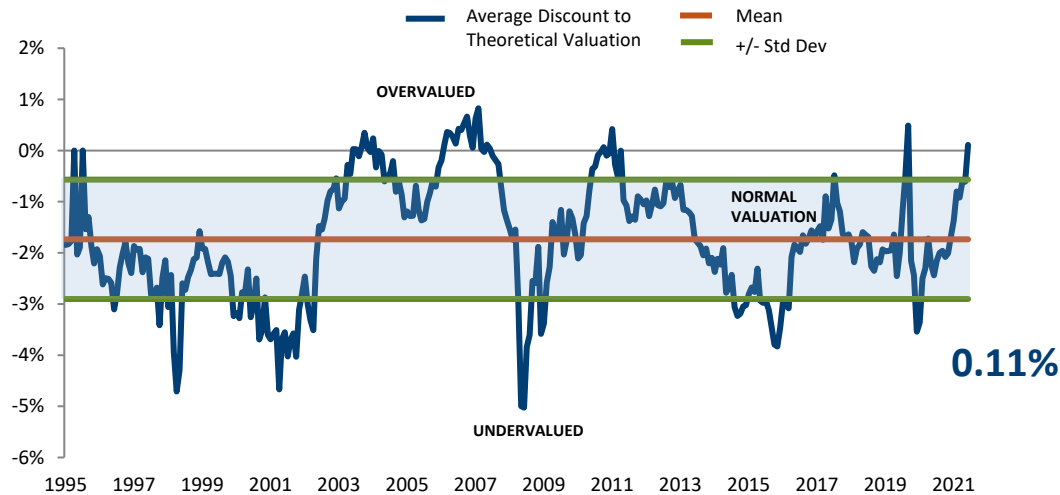

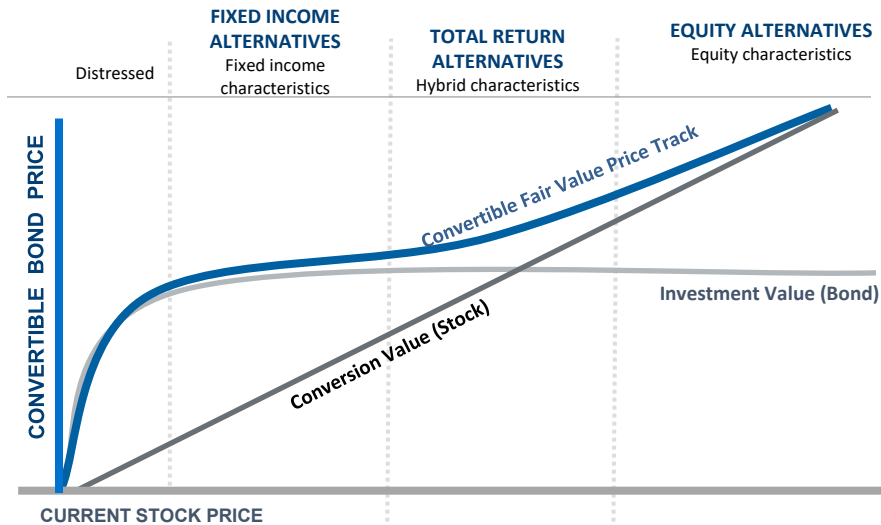
# VALUATION OF THE CONVERTIBLE MARKET

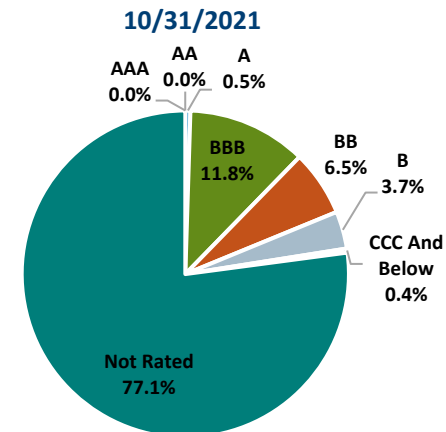
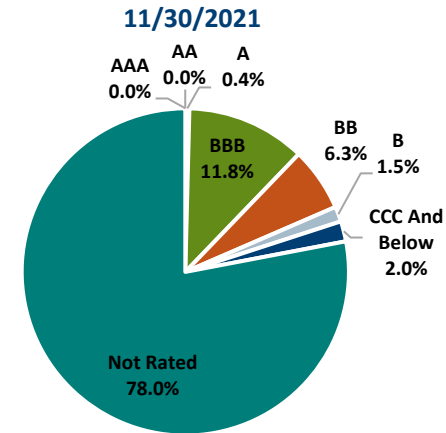
