## OVERVIEW

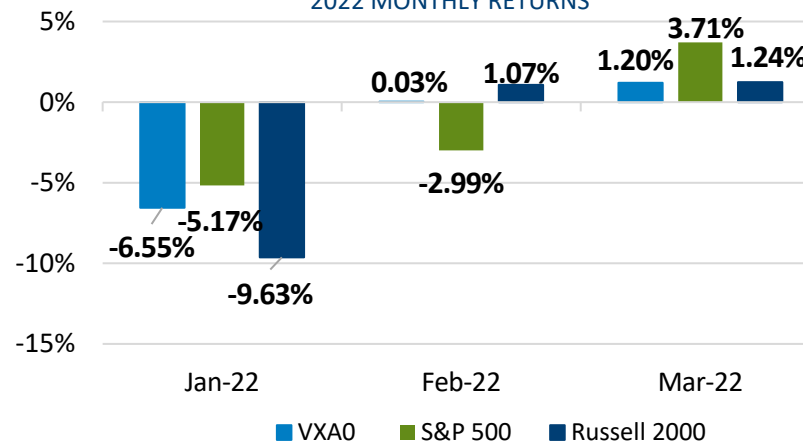

Despite continued concerns over the Russian invasion of Ukraine as well as rising inflation, oil prices and interest rates, the markets found some footing in March. Convertibles posted positive results, with the strongest returns coming from the commodity-focused sectors. Equity-sensitive converts outperformed, and the US was the top geographic region. New issuance volume was subdued in the first quarter, in part due to the heightened global uncertainty. We anticipate that an eventual calming in the overall markets should return volumes back to a more traditional seasonal pace for the balance of the year.

While macro risks have increased, history has shown that periods of short-term volatility can lead to longer term opportunities. The overall equity sensitivity of the convertible market has moved toward the lower end of the post-Covid era range recently. We believe actively managing the changing dynamics of convertibles through volatile times like these can be key in capitalizing on the opportunities.

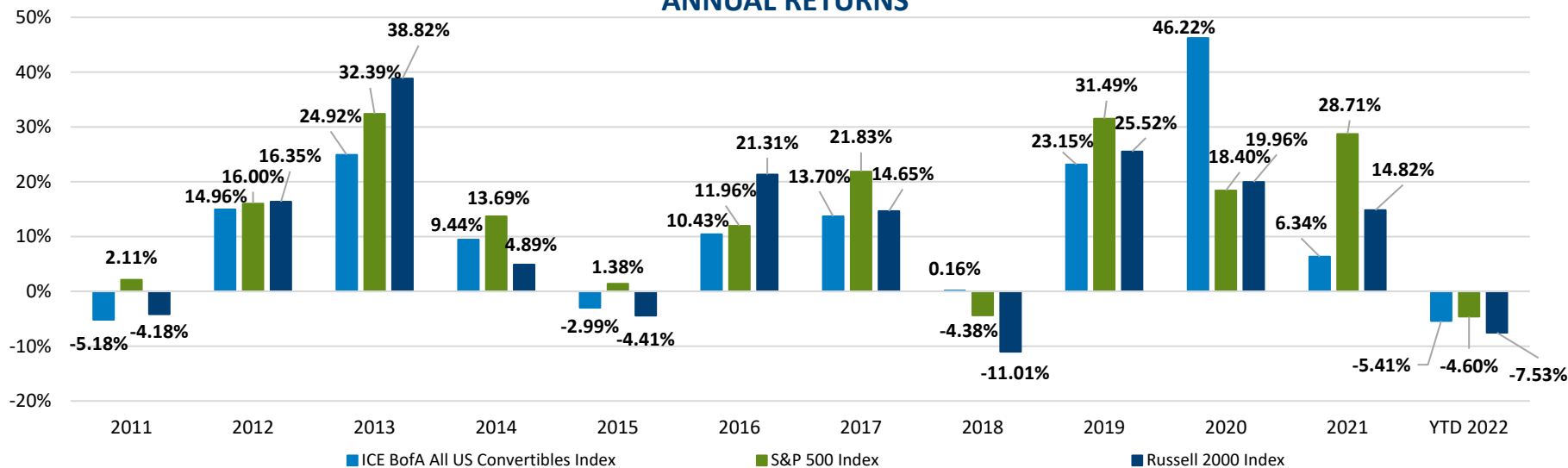
## VXAO vs. S&P 500 vs. RUSSELL 2000

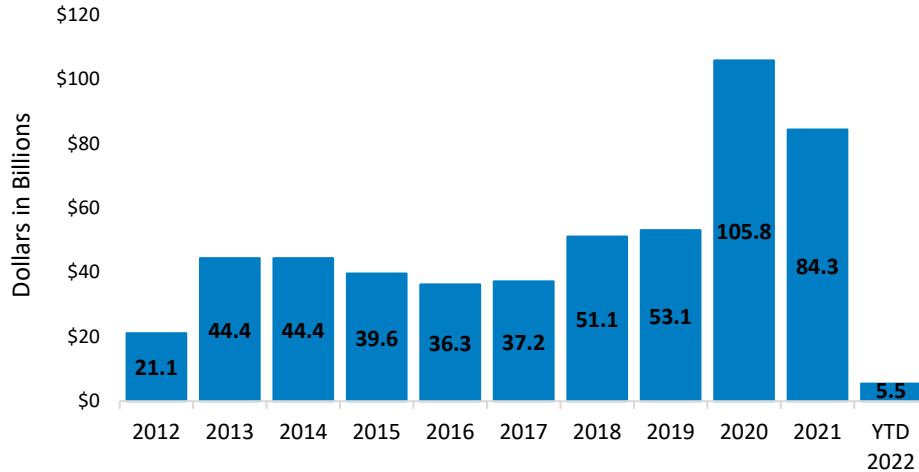
## ANNUAL RETURNS



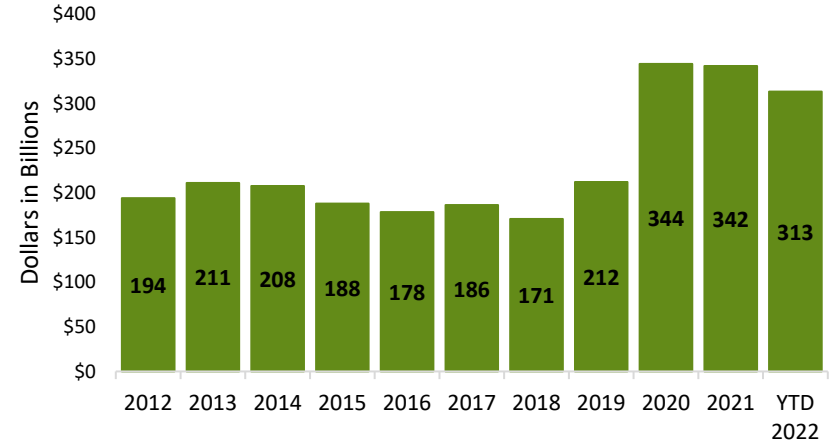

## US Convertible Market ISSUANCE



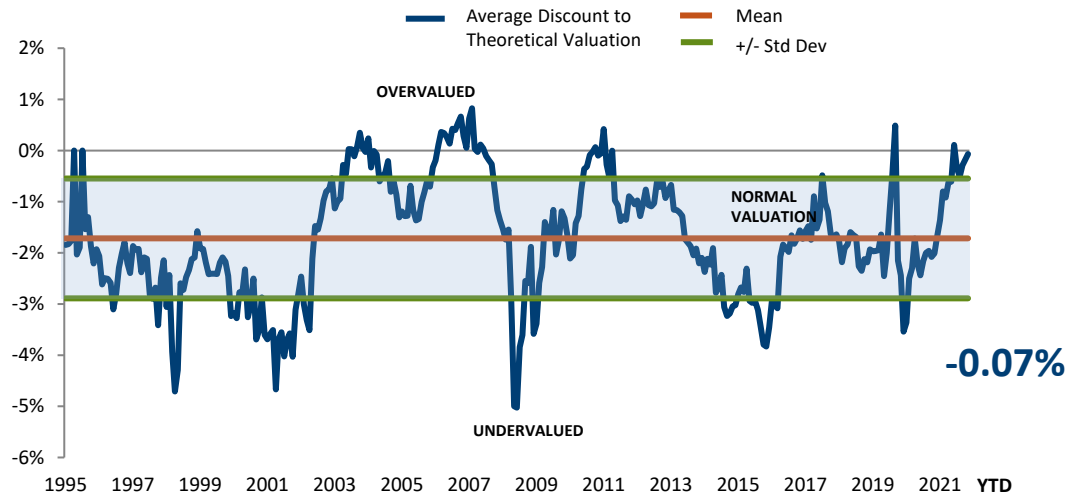

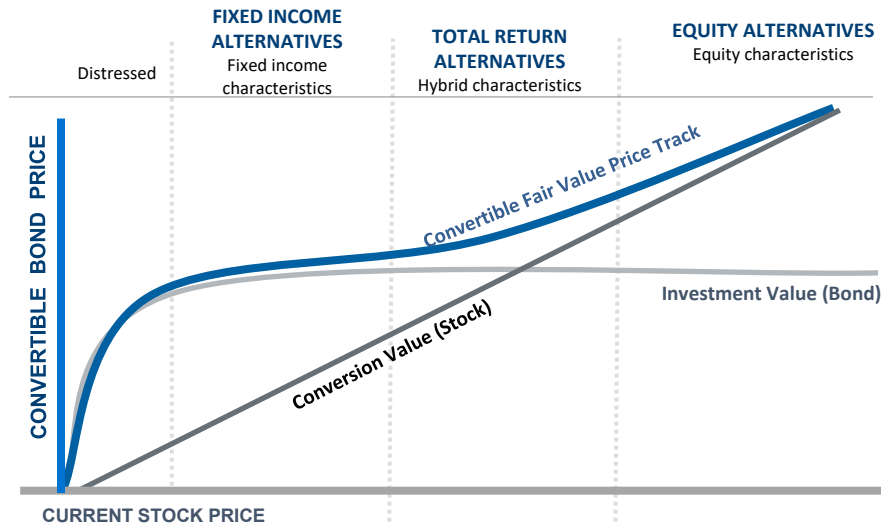
## VALUATION OF THE CONVERTIBLE MARKET

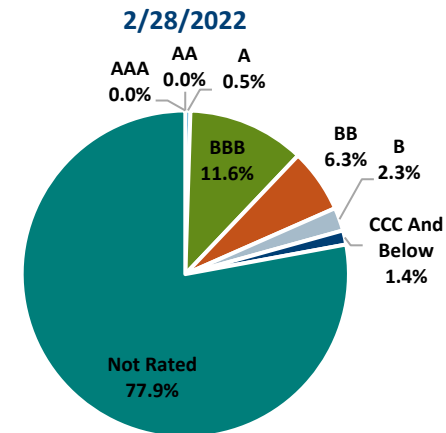
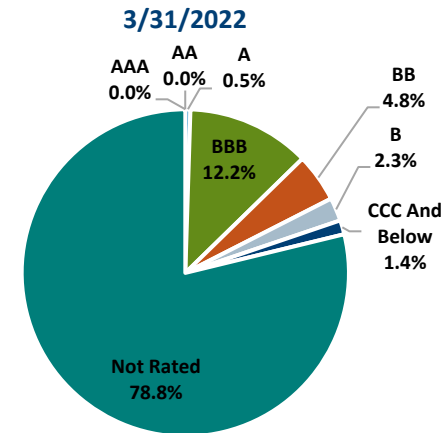
