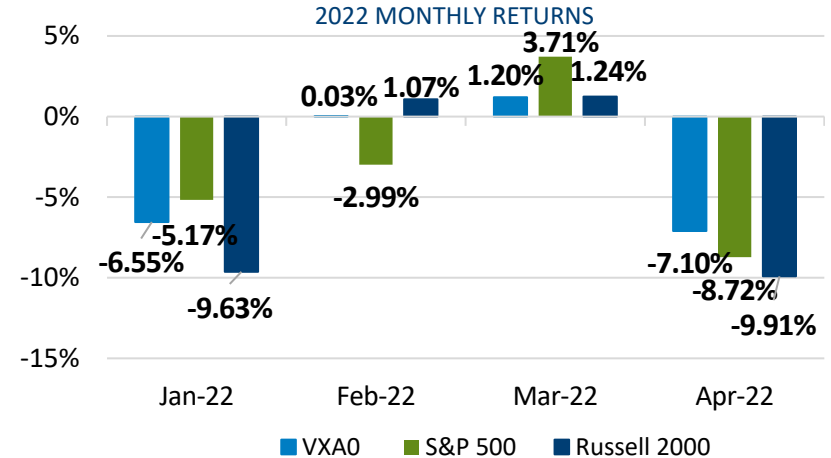
## OVERVIEW

April saw continued pressure within the equity and credit markets, driven by ongoing concerns related to high inflation, central bank policy, rising interest rates, Russia and Ukraine political strife, and the impact of supply chain disruptions on corporate earnings. Against this formidable backdrop, convertibles declined along with other risk assets. The market volatility also continues to dampen IPO activity across asset classes, including the convertible market where new issuance remains below the typical seasonal pace.

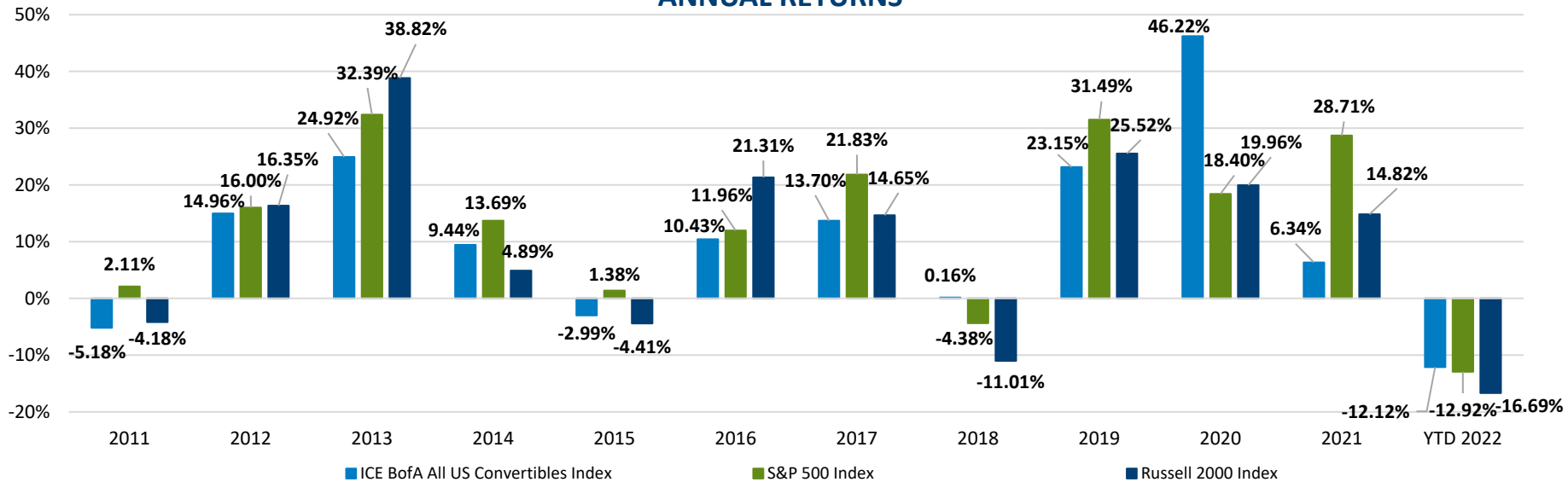
The pullback in underlying equities we have seen in recent months has pushed the overall equity sensitivity of the convertible market to levels we have not had in almost a decade. Actively managing the changing dynamics of convertibles through uncertain times like these can be key in capitalizing on the longer-term opportunities brought on by the volatility.

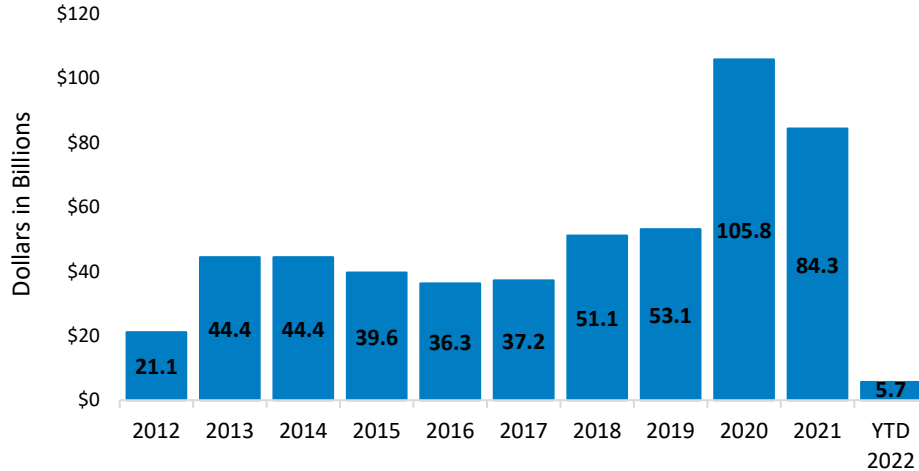
## ANNUAL RETURNS



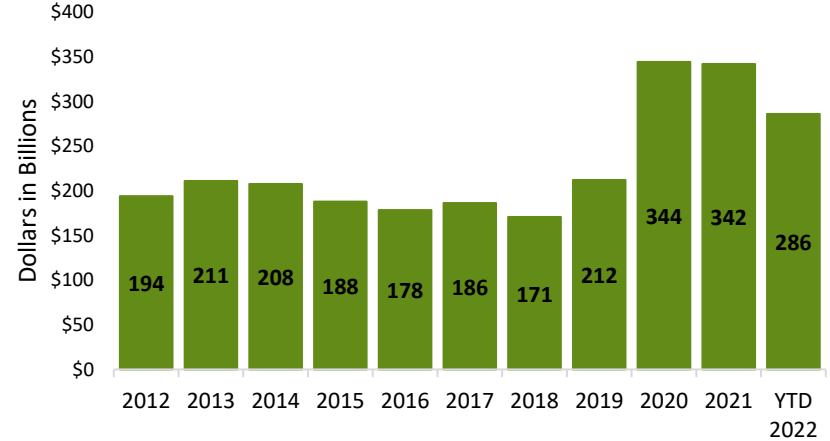

## US Convertible Market ISSUANCE



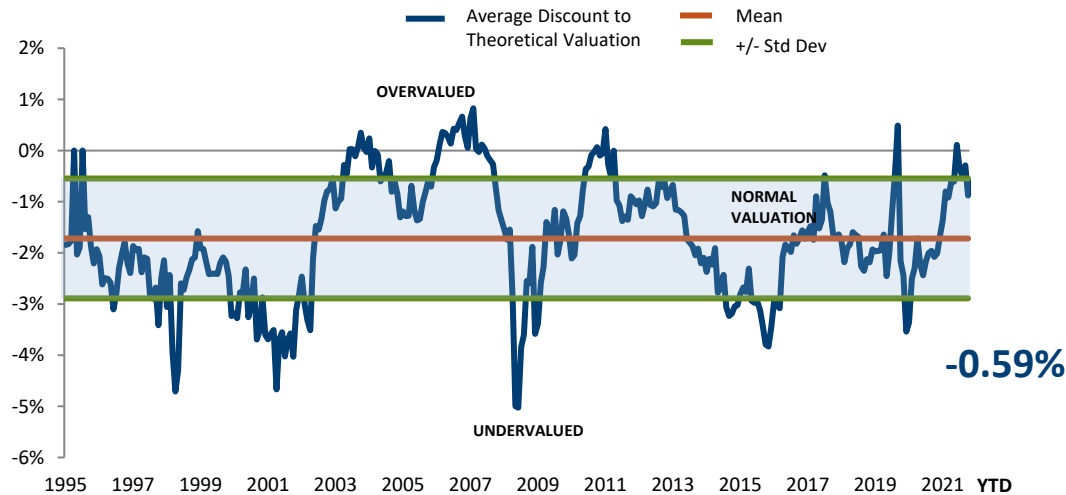

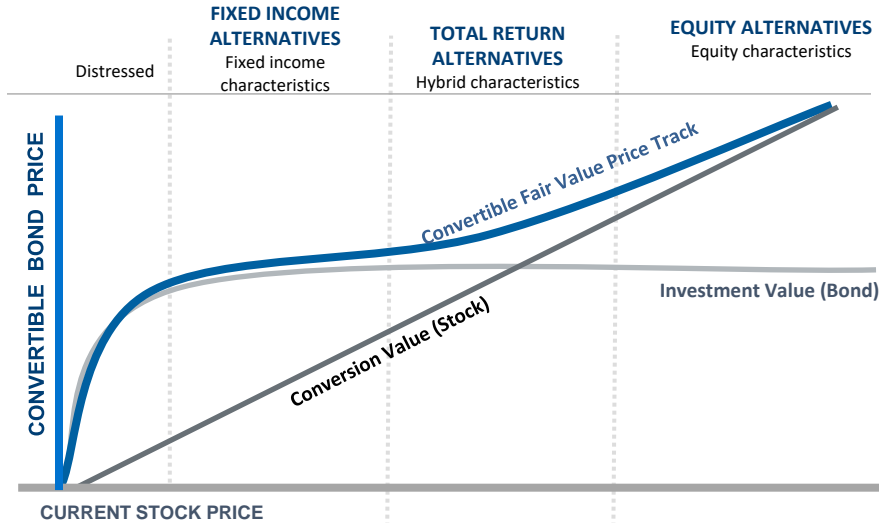
## VALUATION OF THE CONVERTIBLE MARKET

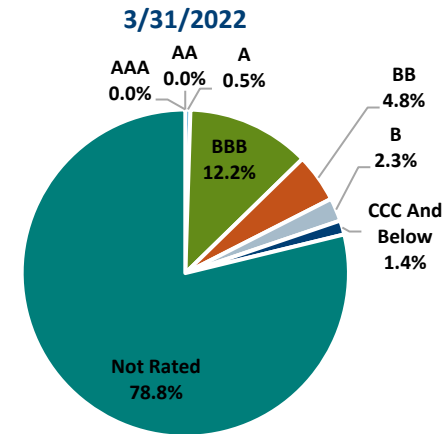
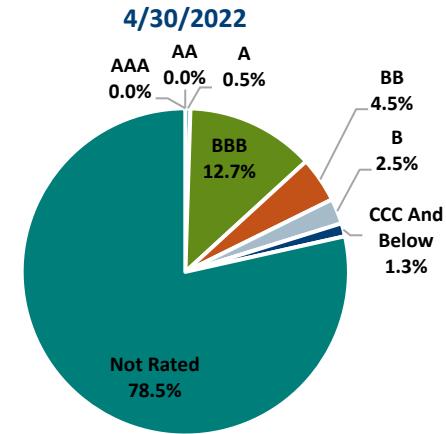

**Investment Premium** is the amount that the market price of the convertible is above its investment value, expressed as a percent of the investment value.
