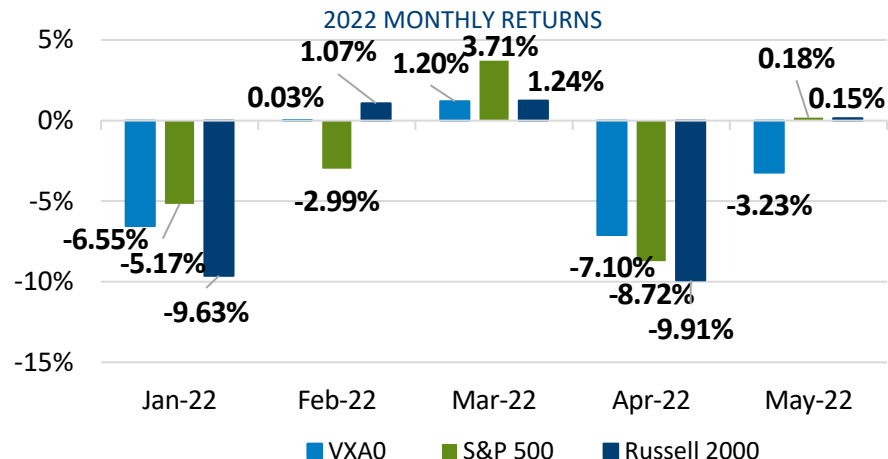
## OVERVIEW

May was another turbulent month in the financial markets as the debate around inflation, economic growth and the path of monetary policy continues to dominate headlines. This uncertainty also continues to weigh on new convertible issuance which remained subdued with just \$10 billion YTD, well below the amount typically seen by this time of year.

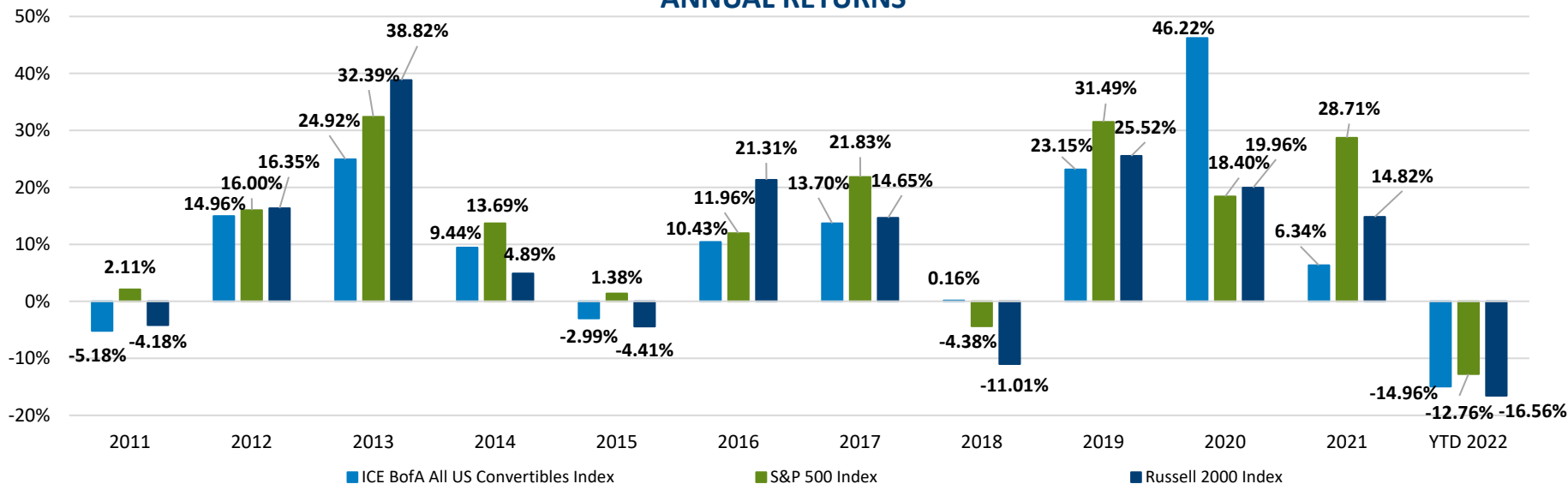
Stepping back, we think the convertible market is at an interesting spot. While declining equity prices and wider credit spreads have been a drag on total return this year, lower equity sensitivity and an increasing amount of convertibles closer to their bond floors could argue for improved structural downside protection going forward. At the same time, reduced equity valuations coupled with longer term optionality and lowered price points on bonds can be powerful drivers for future upside returns. Ultimately, only time will tell how the macro uncertainty plays out, but we believe focusing on the risk/reward can be key to navigating through volatile times.

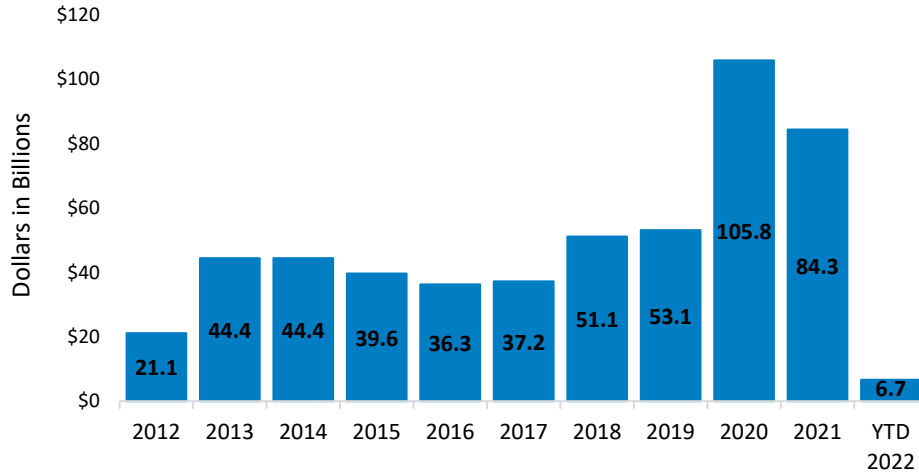

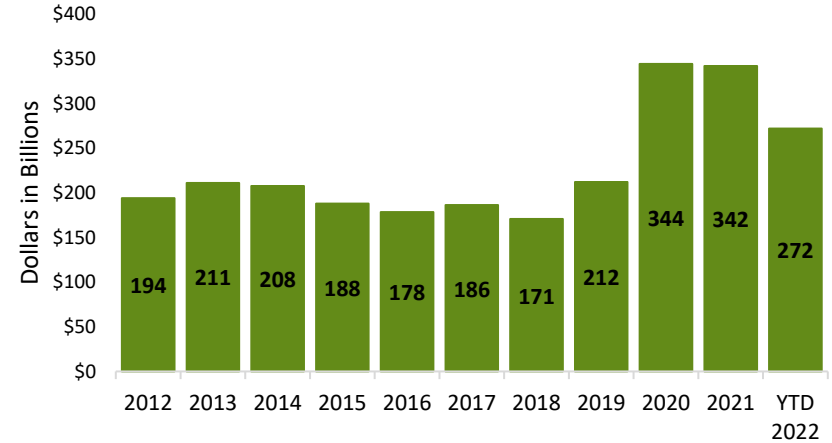

## US Convertible Market ISSUANCE



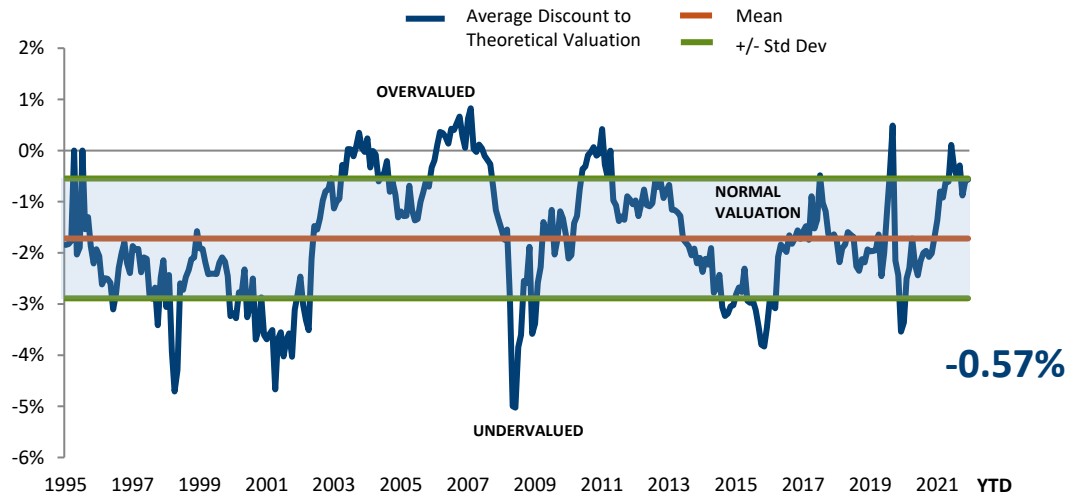

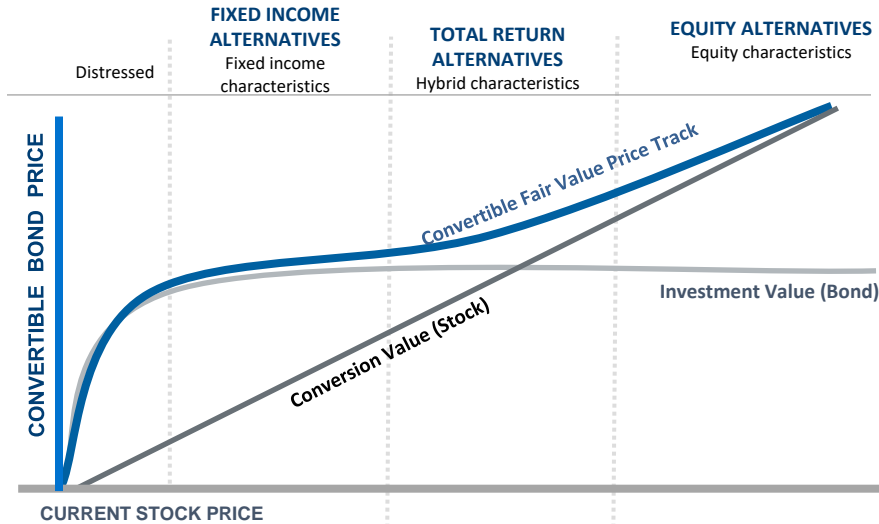
## VALUATION OF THE CONVERTIBLE MARKET

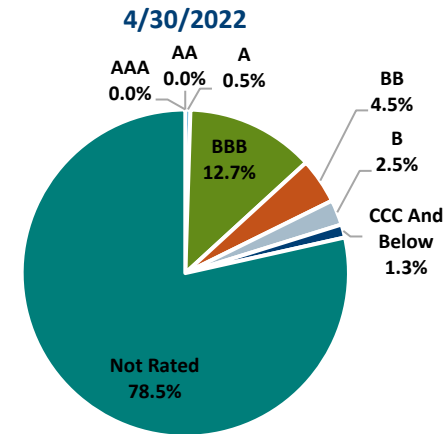
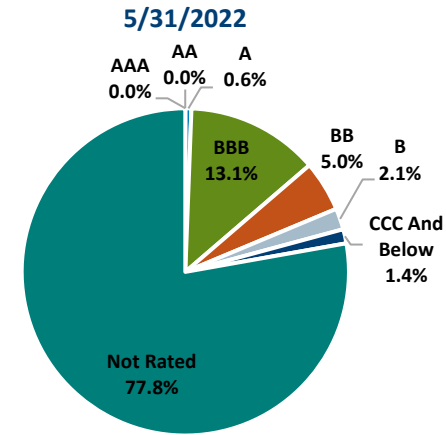
