## OVERVIEW

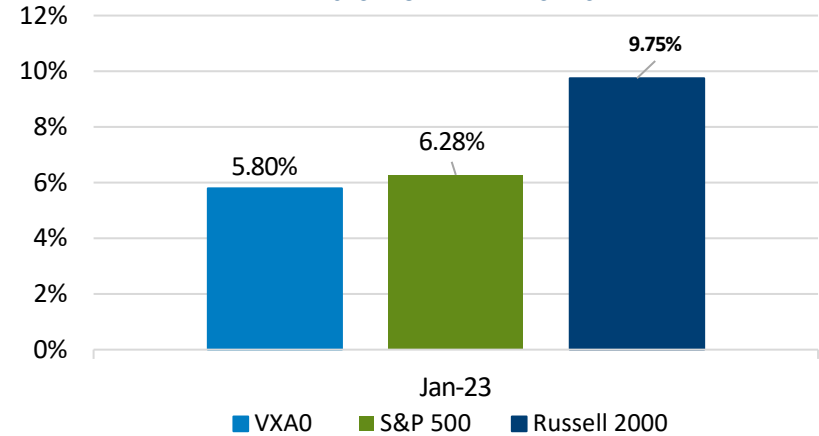

The convertible market got off to a strong start for the new year, driven by gains in underlying equities coupled with a solid rally in the credit markets. On a sector basis, there was broad strength led by issuers from the materials and consumer discretionary sectors, whereas the only economic sector that declined during the month was utilities.

All convertible profiles posted positive returns with notable strength in busted converts, which have proven quite resilient over recent months. While we are only one month into the new year, we are encouraged by these early trends and continue to view convertibles as an attractive risk-managed way to gain exposure to the upside potential of equities while also providing structural downside risk mitigation.

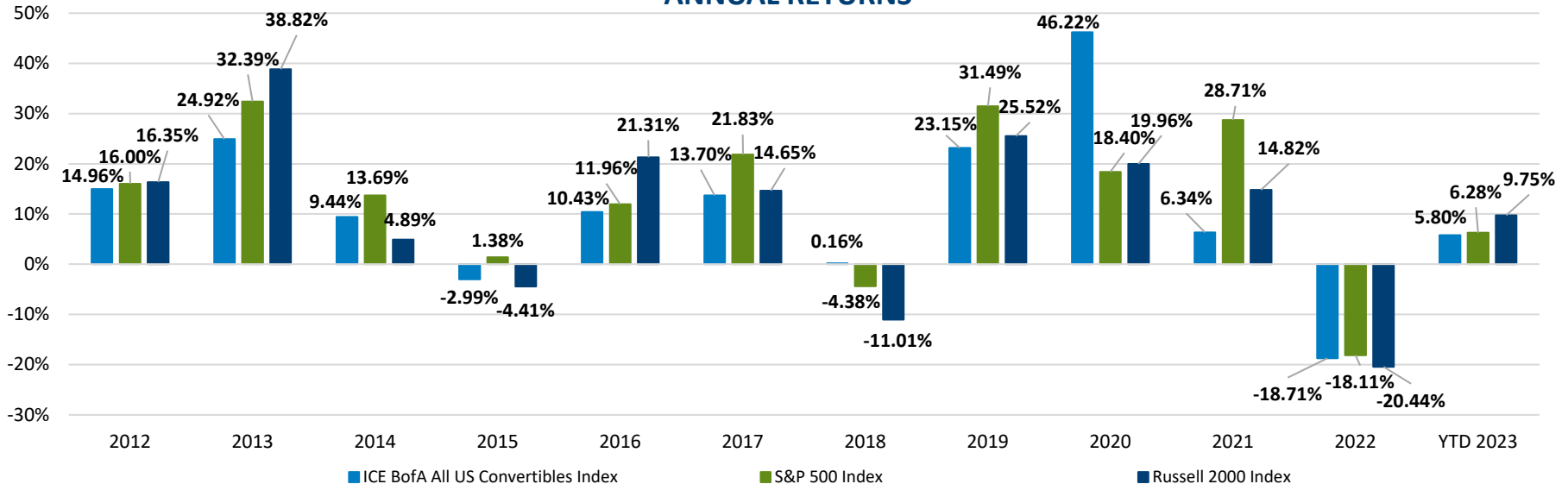
## VXAO vs. S&P 500 vs. RUSSELL 2000

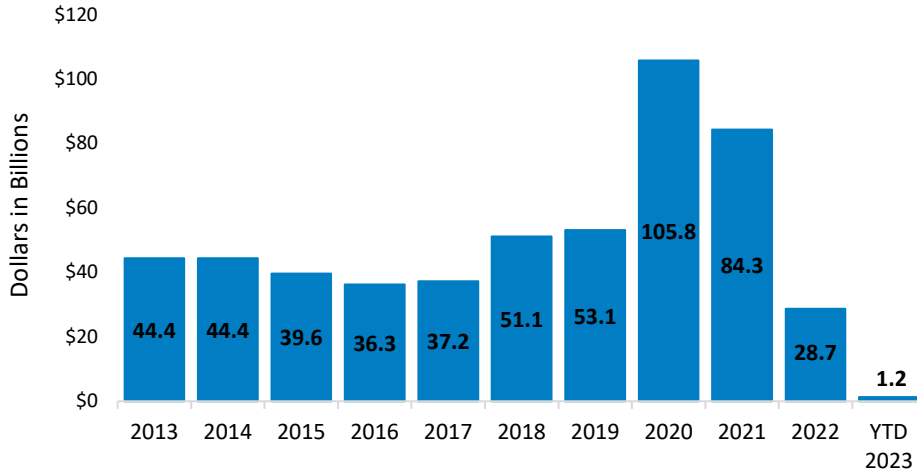
## ANNUAL RETURNS



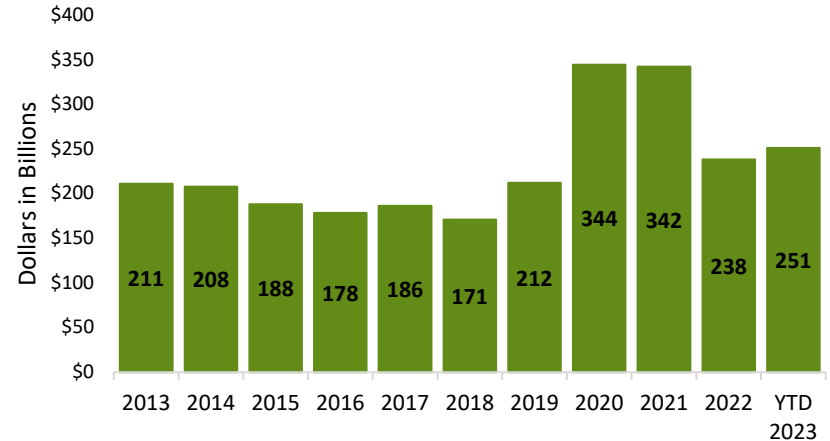

# US Convertible Market ISSUANCE



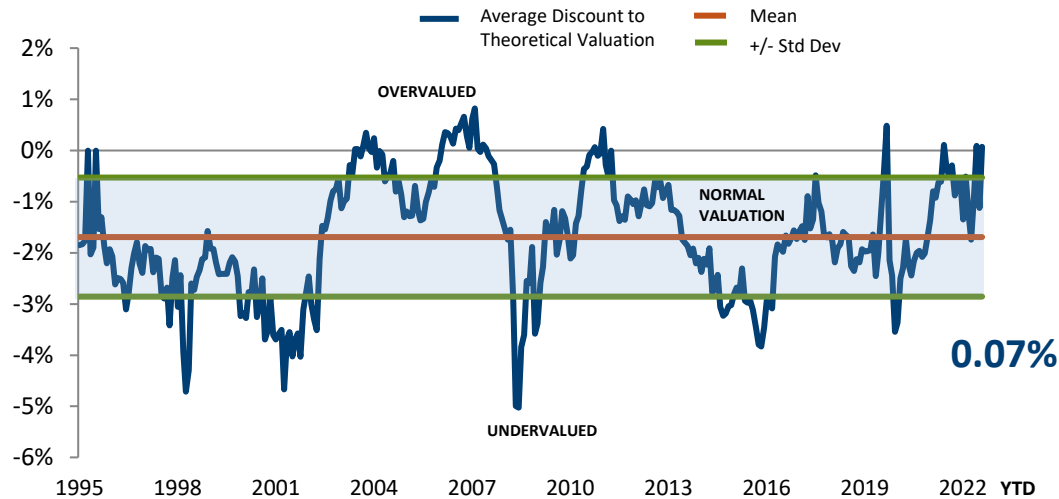

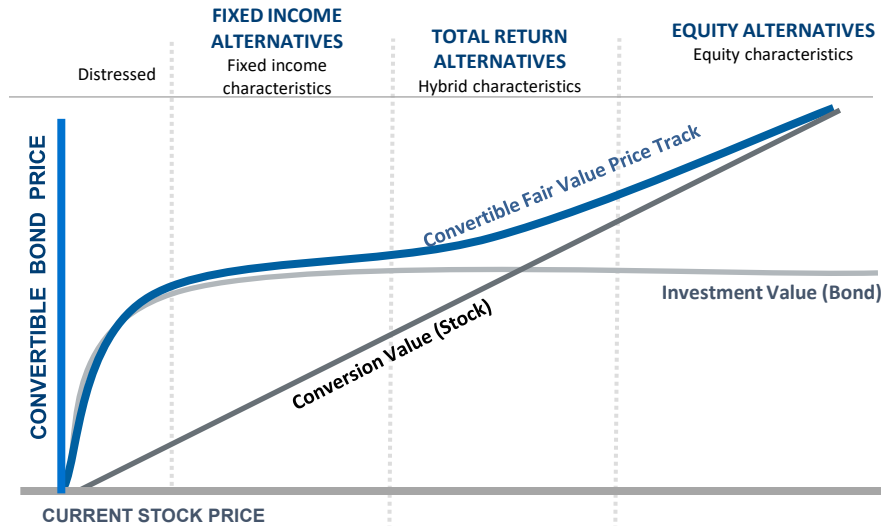
# VALUATION OF THE CONVERTIBLE MARKET

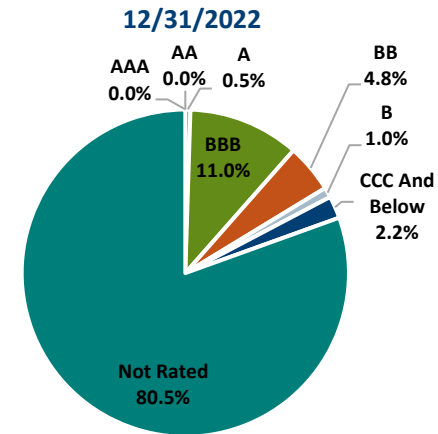
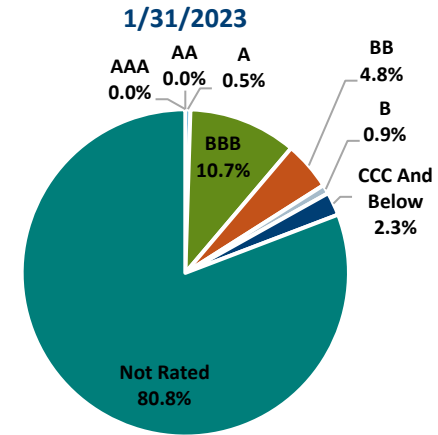

**Investment Premium** is the amount that the market price of the convertible is above its investment value, expressed as a percent of the investment value.
