
US Convertible Market Snapshot


OVERVIEW

March was a volatile month for risk assets as investors faced concerns about the banking sector, ongoing inflation and the prospect of a recession. Despite all the headlines during the month, convertibles remained mostly unchanged as gains in more defensive areas offset declines in more cyclically focused sectors. Global new issuance was \$6 billion for the month and brought the 1Q23 total to a respectable \$20 billion. We are seeing a broader array of companies coming to the convertible market with more investment-grade-rated deals and less from the technology and healthcare sectors, which have represented close to 50% of volume in recent years. Only time will tell, but if this trend continues, the increased sector diversity and improved credit quality could provide an element of stability to balance other more growth-focused sectors over the coming years. Although unexpected macro events again grabbed the headlines during the month, we continue to view convertibles as an attractive riskmanaged way of gaining exposure to the upside potential in equities while also incorporating structural downside risk mitigation.






US Convertible Market


VALUATION OF THE CONVERTIBLE MARKET




CONVERTIBLE MARKET COMPOSITION AS OF 3/31/23
