### **OVERVIEW**



June was a solid month for the convertible market driven by gains in underlying equities coupled with a stable credit backdrop. We were particularly encouraged to see early signs of broadening equity market strength beyond just a handful of mega-cap companies, which have captured most of the attention this year. If sustained, this market-cap expansion can provide a positive tailwind for convertible issuers, which tend to be more mid-cap, growth-orientated companies. Consumer Discretionary was the strongest sector within the convertible market. However, there was broad strength as every economic sector posted positive returns for the month. Global new issuance came in at \$6 billion, bringing the year-to-date total to just under \$40 billion and matching the amount from the entire calendar year 2022. While June is only one month, we are encouraged by these trends and view convertibles as an attractive riskmanaged way to gain exposure to the upside potential in equities while also providing structural downside risk mitigation.






### **US Convertible Market ISSUANCE**


### VALUATION OF THE CONVERTIBLE MARKET




