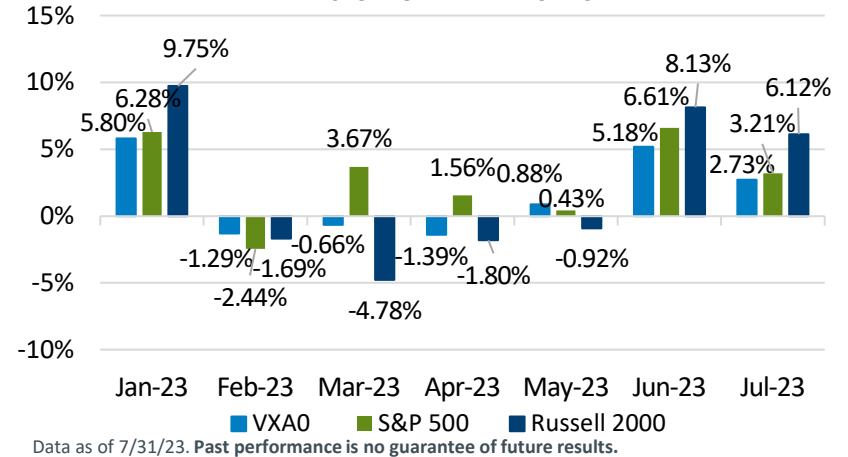
## OVERVIEW

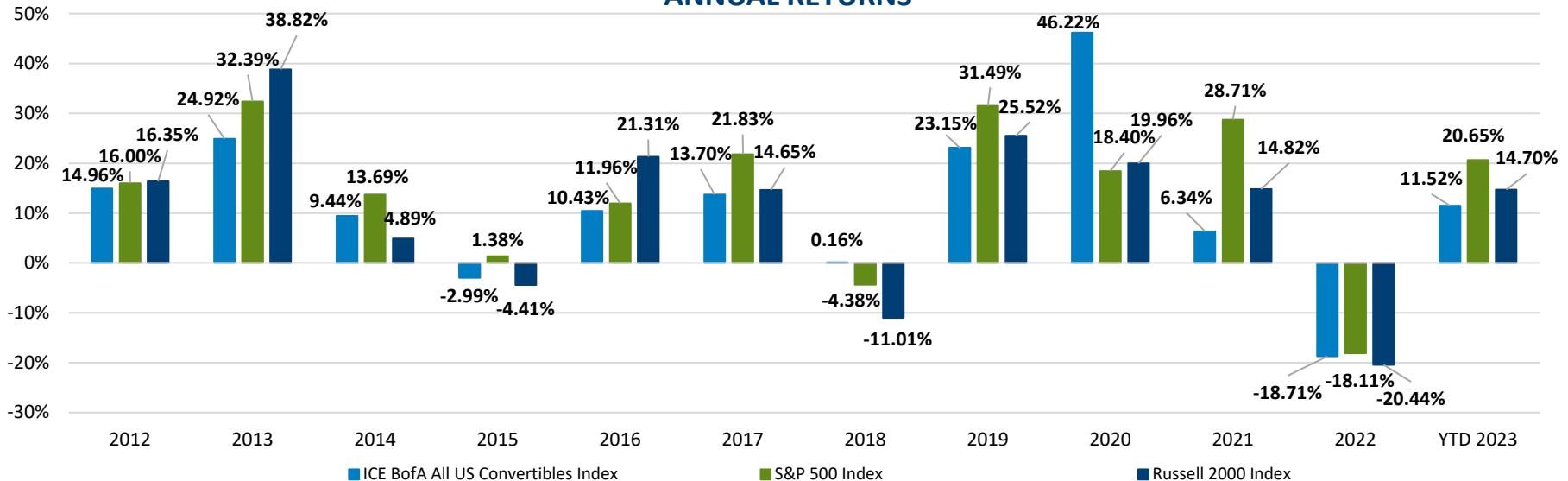
The convertible market gained in July as the underlying equities appreciated and credit remained steady. Technology and consumer discretionary were the leading contributors, although all the economic sectors posted positive returns. Balanced convertibles had a solid month as well, outperforming both equity-sensitive and busted convertibles. July is typically the slowest month for convertible new issuance because many companies are entering quiet periods before reporting quarterly earnings. This year was no different, and all new convertibles that came to the market in July were from outside the US. The year-to-date global issuance of \$43 billion now exceeds the total brought to market in the prior calendar year, and we believe the tailwinds promoting convertible issuance will persist as we head into the back half of the year and beyond.

2023 MONTHLY RETURNS



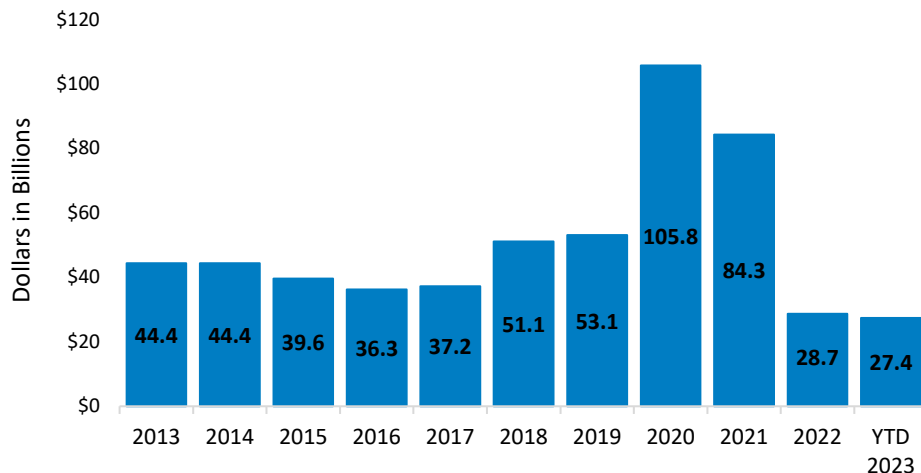

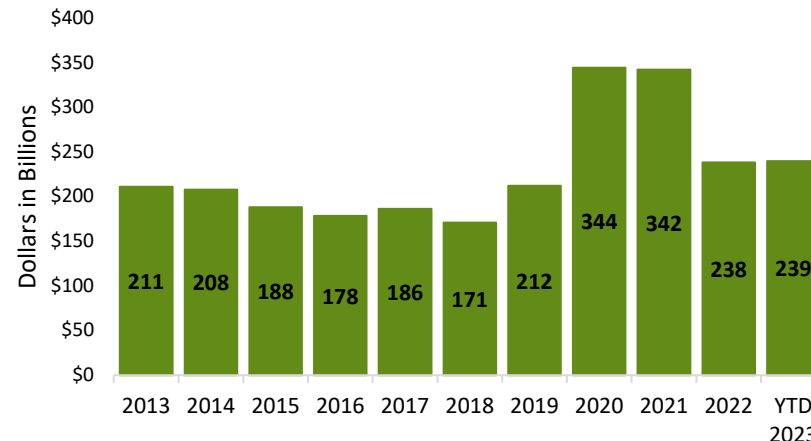

## US Convertible Market ISSUANCE



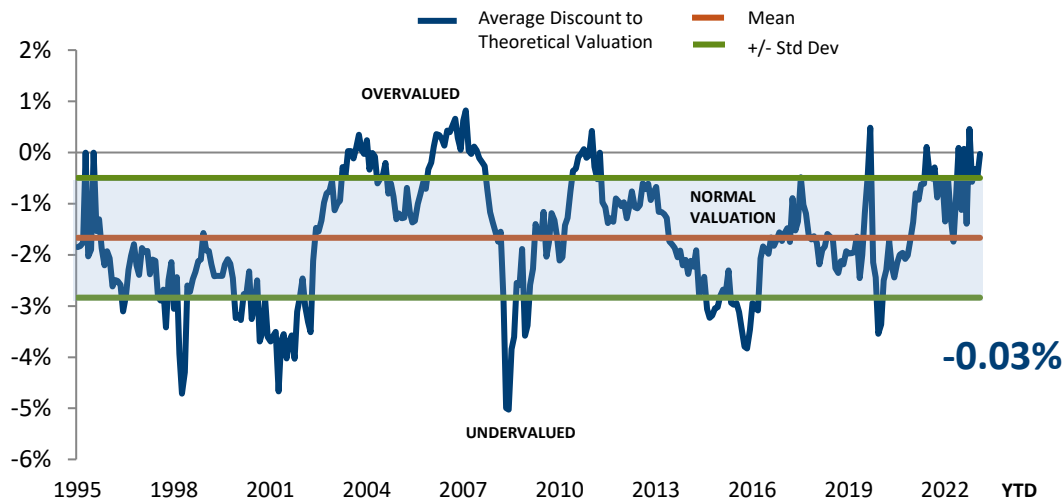

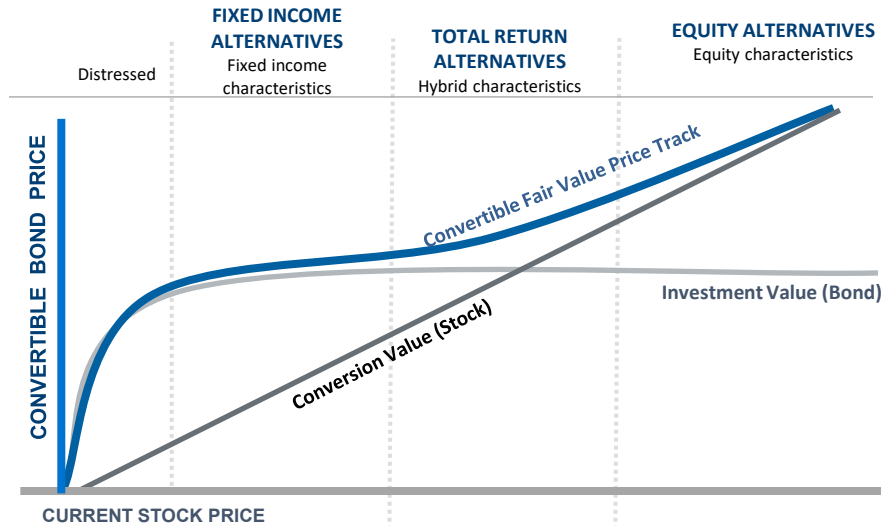
## VALUATION OF THE CONVERTIBLE MARKET

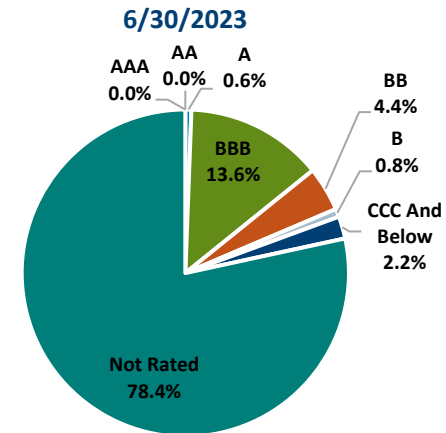
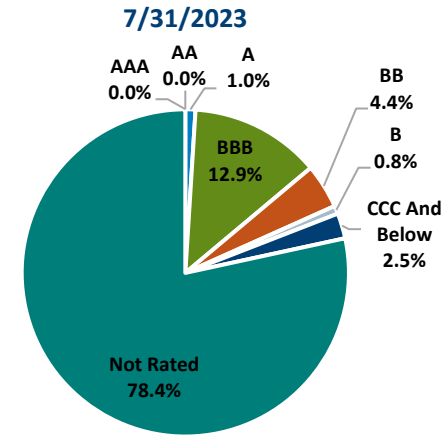
