OVERVIEW

As represented by the ICE BofA All US Convertibles Index (VXA0), US convertibles rose 5.21% in November and participated in the broad equity market advance, as captured by the S&P 500 Index's 9.13% return. The underlying stocks of the convertible index also outperformed the broader market and increased 12.38% on average. Except for energy (-2.9%), every economic sector within the convertibles index had positive November results. Information technology (+7.5%), financials (+6.9%), and consumer discretionary (+6.6%) led. In addition to energy (-2.9%), communication services (+0.9%) and consumer staples (+1.8%) lagged the most. As expected with the strong November equity market, convertibles with the most equity sensitivity (+11.1%) outperformed. In November, \$9.6 billion in new convertibles were brought to the global market. The United States led issuance higher with \$5.5 billion, Europe raised \$3.1 billion, while Japan and Asia ex-Japan introduced \$757 million and \$300 million, respectively.










CONVERTIBLE MARKET COMPOSITION AS OF 11/30/23


