

US Convertible Market Snapshot

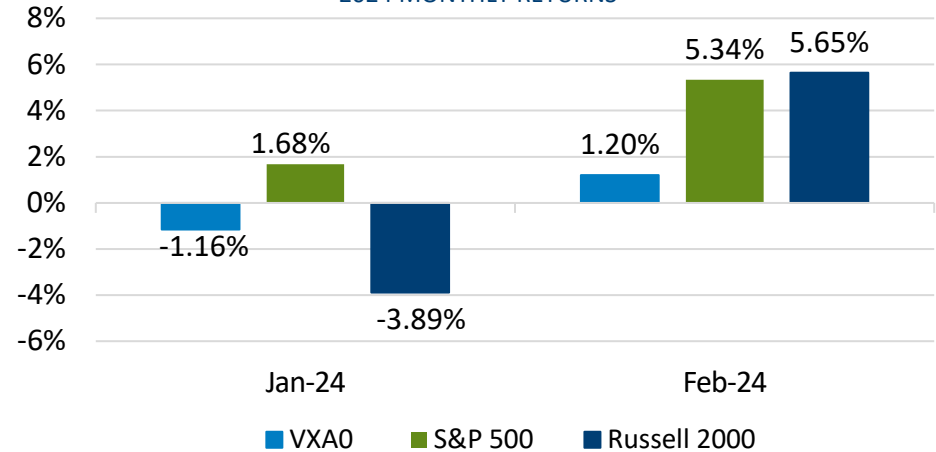

OVERVIEW

As represented by the ICE BofA All US Convertibles Index (VXA0), the US convertible market rose 1.20% in February versus the broad equity market's 5.34% return, as represented by the S&P 500 Index. And the underlying stocks of the convertible index returned 2.21% on average, underperforming the broader market. Given their close relationship to small caps, the performance of convertibles has been disappointing year-to-date. Fortunately, the outlook for small-cap equities appears more favorable from here, given the peaking rates cycle, which has historically benefited small caps. Specific to the convertibles' index, the economic sectors that performed best for the month included consumer staples (+8.79%), materials (+7.86%), and industrials (+5.65%), whereas utilities (-1.40%), consumer discretionary (-0.84%), and real estate (-0.22%) most trailed the index. In February, \$9.1 billion in new convertibles were brought to market globally. The United States led convertible issuance higher with \$7.9 billion, and Japan raised \$1.4 billion.

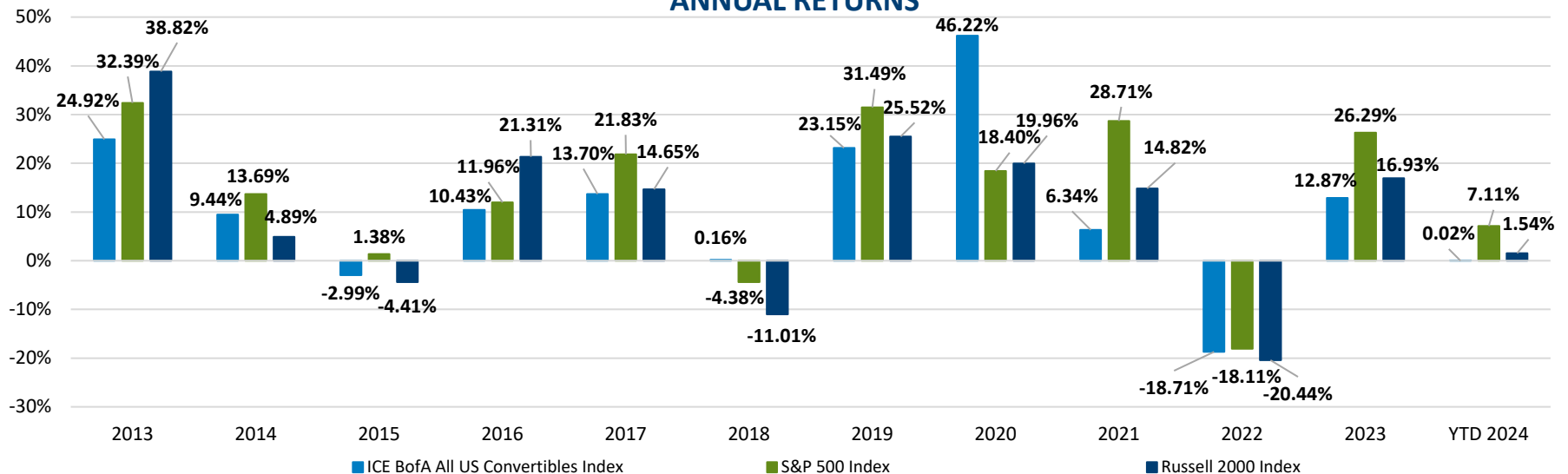
VXA0 vs. S&P 500 vs. RUSSELL 2000

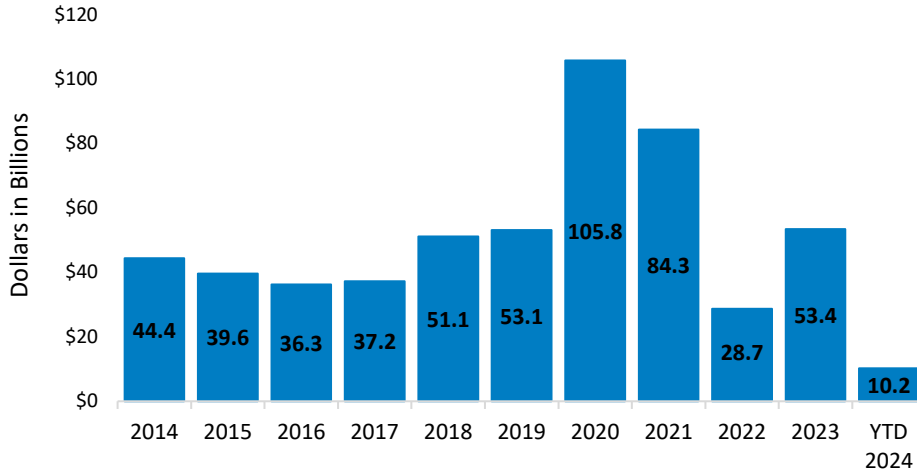
ANNUAL RETURNS



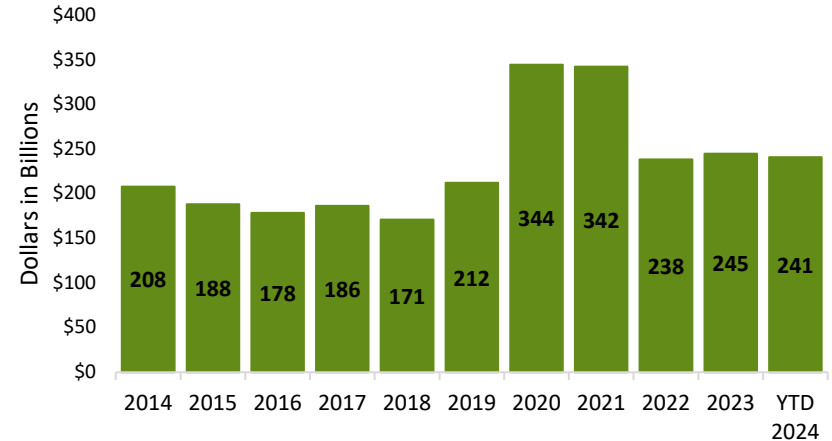

US Convertible Market ISSUANCE



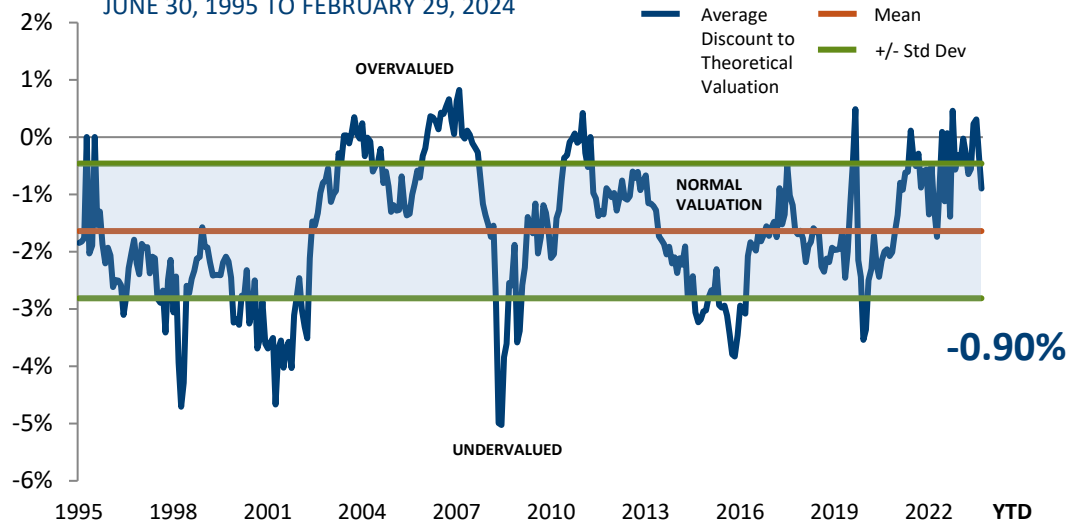

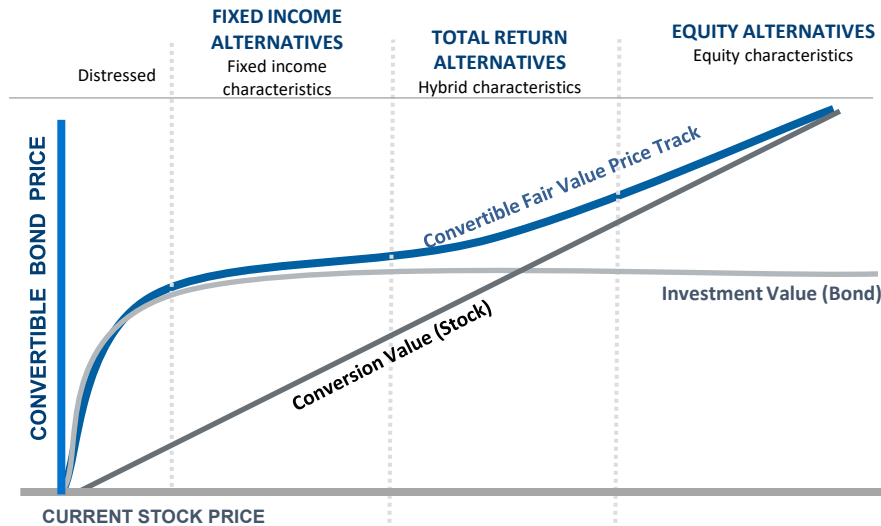
VALUATION OF THE CONVERTIBLE MARKET

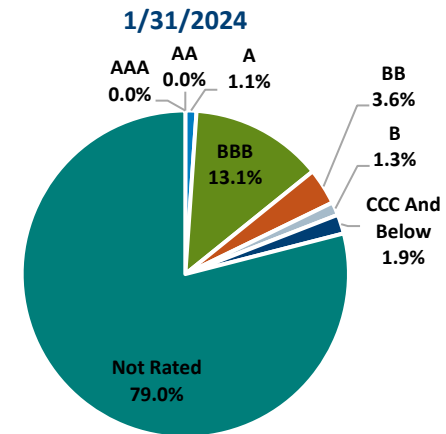
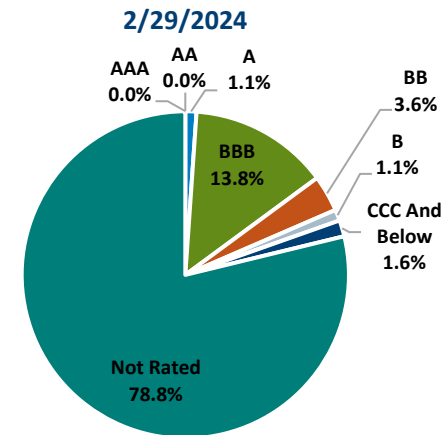
