OVERVIEW

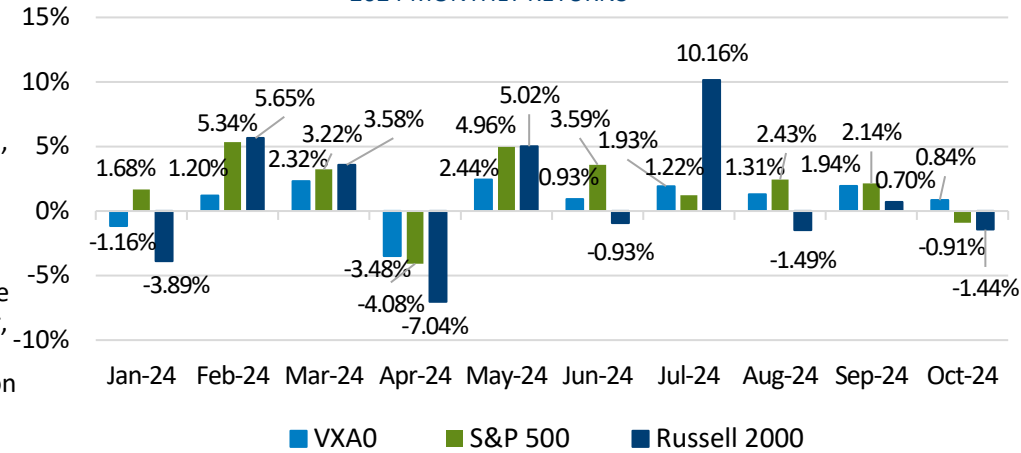
Driven by their underlying equities' outperformance, convertibles marked their sixth-consecutive monthly gain, returning 0.84% in October as measured by the ICE BofA All US Convertibles Index (VXA0) and outperforming the S&P 500 and Russell 2000 Indexes.

Convertibles within the materials (+4.1%), consumer discretionary (+2.7%), and technology (+2.4%) sectors performed best within the index. Convertibles in the consumer staples (-3.4%), utilities (-2.1%), and health care (-2.1%) sectors most lagged the VXA0 index result.

The first month of each new quarter generally sees a slowdown in issuance because of the quiet period preceding earnings announcements. However, October bucked this trend, and global convertible issuance totaled \$11.1 billion per BofA data. From a regional perspective, the US raised \$9.5 billion (with six securities priced), Japan issued \$147 million, Asia ex-Japan raised \$1.3 billion, and Europe had no new supply.

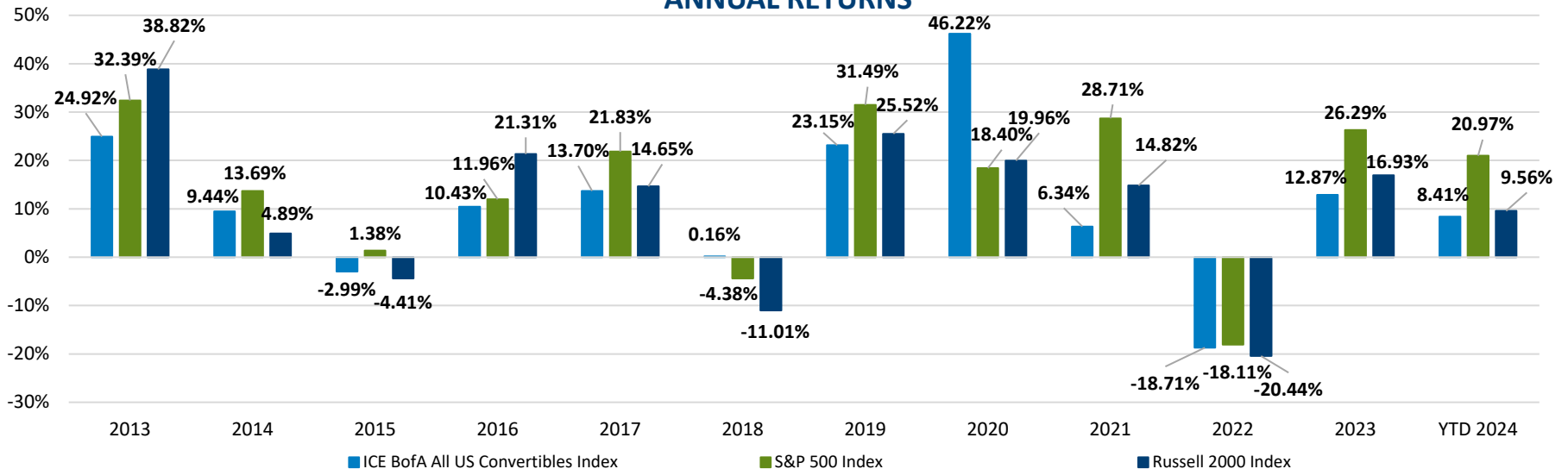
VXA0 vs. S&P 500 vs. RUSSELL 2000

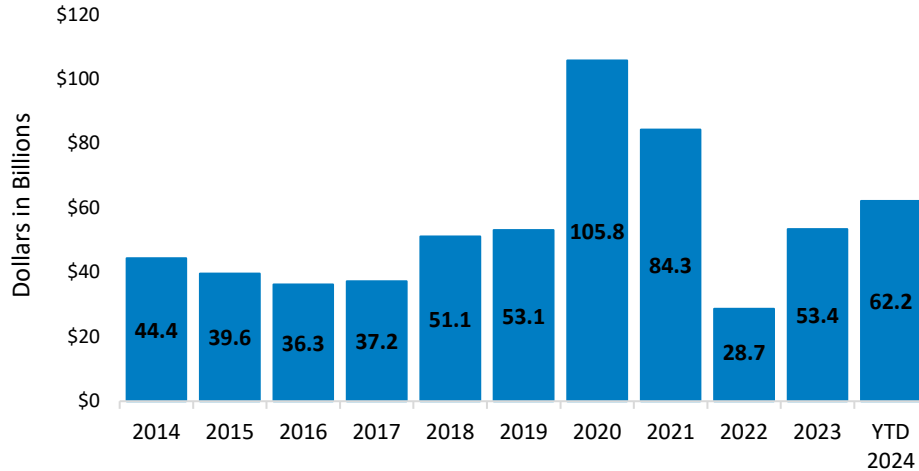
ANNUAL RETURNS



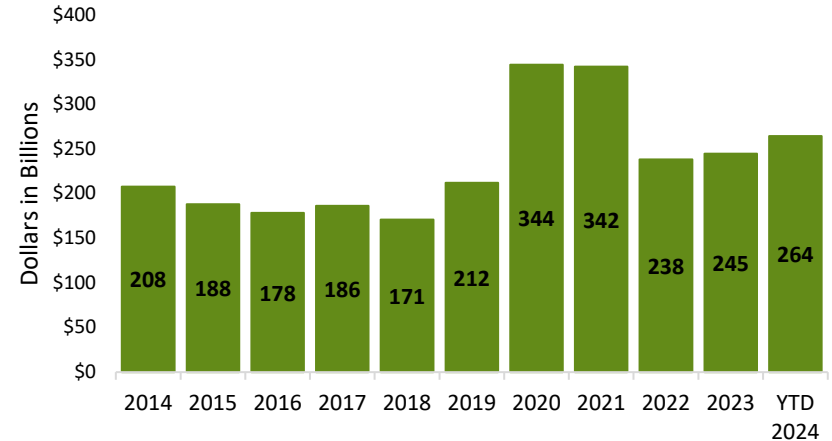

US Convertible Market ISSUANCE



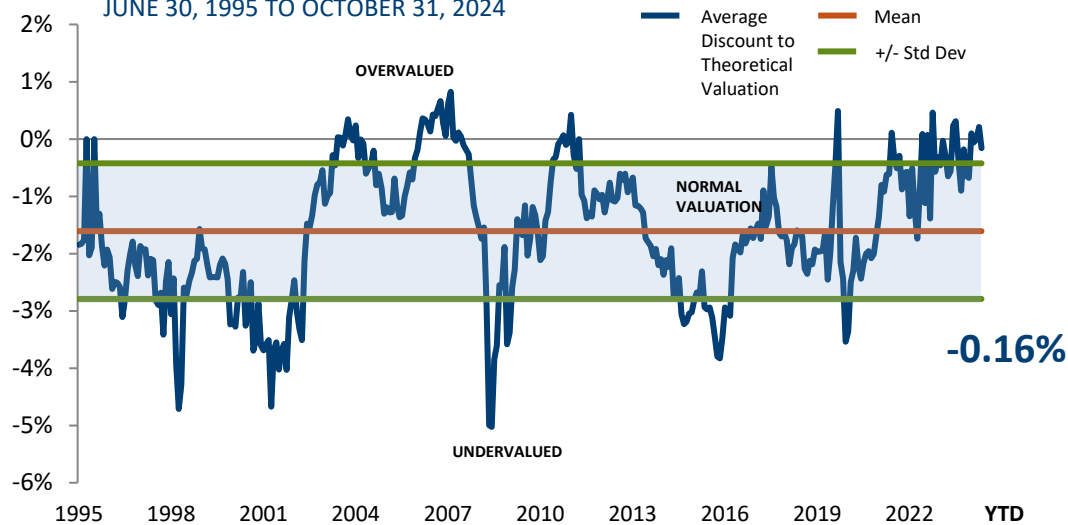

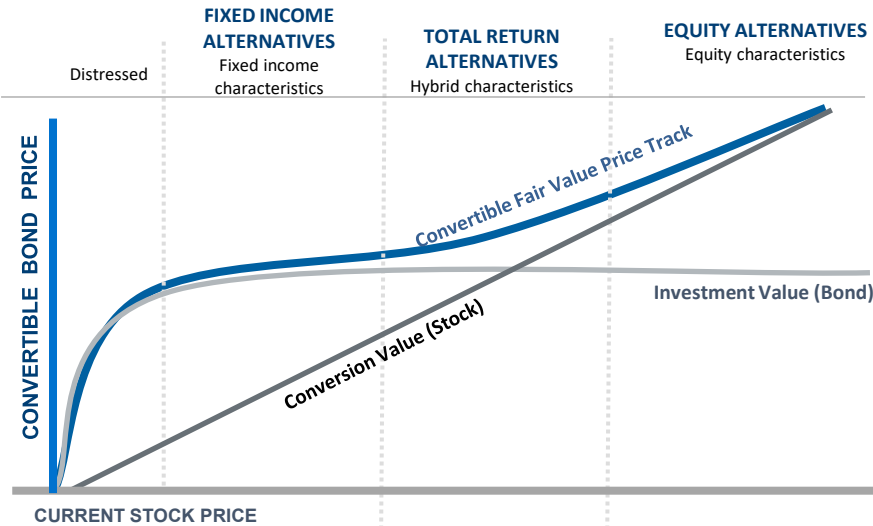
VALUATION OF THE CONVERTIBLE MARKET

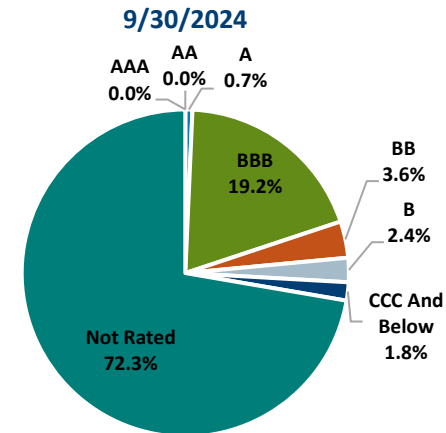
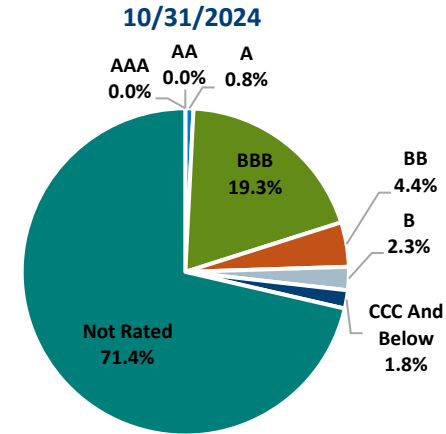

Current Yield reflects the dividends and interest earned during the 30-day period ended as of the date stated above after deducting expenses for that same period.

Investment Premium is the amount that the market price of the convertible is above its investment value, expressed as a percent of the investment value.
