Linking Passive Investing and the Concentration of Economic Power

WEEKLY HEADLINES

A backlash against industry consolidation—as driven by the meteoric rise of passive investing—is coming, predicts a recent <u>13D Research blog post</u>.

The post offers the following indicators that the market is becoming "dangerously extreme, offering opportunity only to already-entrenched corporate superpowers":

- Indexing's bias for bigness has resulted in the 10 largest stocks in the S&P 500 and the Russell 1000 now accounting for 23% and 21% of the total index market cap, respectively.
- While U.S. equity indexes set all-time highs, the percentage of listed companies in the U.S. losing money over 12 months is close to 40%.
- But of the 100 biggest money-losing companies, roughly 75% gained in value over the same 12 months.

"How and when concern about indexing turns to action remains unknown," the post says. In the meantime, "excesses will only grow."


