'Herd of Newbies' Charge into Trading Accounts Investors jumping into the market at precisely the wrong time is a familiar story. But a recent Business Insider article comments on the "herd of newbies" charging into trading at a time of such uncertainty that hundreds of companies have canceled their 2020 earnings guidance. Citing a Financial Times report, the article says many of the 780,000 brokerage accounts created during the pandemic are in pursuit of riches associated with the discovery of a COVID-19 vaccine or treatment. The problem, according to BI: "We have bored, unseasoned, emotionally conflicted investors playing around in a murky pool where one of the most opaque sectors [pharmaceuticals] has the ability to make the biggest waves." #### **Definitions and Disclosures**

The Nontraditional Bond category contains funds that pursue strategies divergent in one or more ways from conventional practice in the broader bond-fund universe. Multialternative funds offer investors exposure to several different alternative investment tactics. Funds in this category have a majority of their assets exposed to alternative strategies. Bear Market funds dedicate a majority of the fund's assets to equities. Most of the portfolio is dedicated to short stock positions in an attempt to take advantage of anticipated market or stock declines. Managed Futures funds primarily trade liquid global futures, options, swaps, and foreign exchange contracts, both listed and over-the-counter. Commodities Broad-basket portfolios can invest in a diversified basket of commodity goods including but not limited to grains, minerals, metals, livestock, cotton, oils, sugar, coffee, and cocoa. Commodities Precious Metals can invest in precious metals such as gold, silver, platinum, and palladium. Energy Limited Partnership strategies invest a significant amount of their portfolio in energy master limited partnerships, also known as MLPs. Multicurrency portfolios invest in multiple currencies through the use of short-term money market instruments; derivative instruments including and not limited to forward currency contracts, index swaps, and options; and cash deposits.
