## OVERVIEW

The Fund normally invests at least 80% of its assets in a broad range of U.S. dollar-denominated debt securities that have a dollar-weighted average portfolio maturity between three to 10 years.

The debt securities that the Fund may invest in include, among others, obligations of U.S., state, and local governments, their agencies and instrumentalities; mortgage- and asset-backed securities, corporate debt securities, preferred stocks and convertible securities. The Fund will invest primarily in investment grade securities, but also may invest up to 20% of its net assets in below-investment grade securities which are sometimes referred to as high yield or "junk" bonds.

While these securities are primarily U.S. dollar-denominated debt securities, the Fund may invest up to 20% in non-U.S. debt securities, including non-dollar-denominated securities and emerging market securities.

## PORTFOLIO FIT

The Fund may be suitable for investors seeking current income and also capital appreciation over a three-year to ten-year time horizon with a moderate level of volatility.

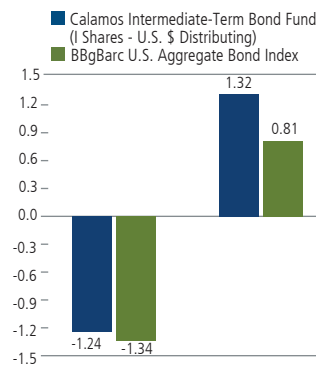

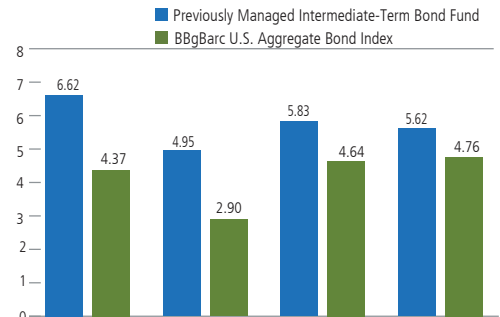
